ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF MANKATO TO INCLUDE CERTAIN UNPLATTED LANDS NOT EXCEEDING TWO HUNDRED ACRES, PURSUANT TO M.S.A., SECTION 414.03, SUBDIVISION 2, AND ALL LAWS AMENDATORY AND SUPPLEMENTARY THERETO, AND IN ACCORDANCE WITH THE RULES OF PROCEDURE OF THE MUNICIPAL COMMISSION.

The City of Mankato, Minnesota, does ordain:

Ι.

A Petition has been filed with the City Clerk of the City of Mankato, Minnesota, by North Star Concrete Company and Landkamer Brothers Company, as owners of the tracts of land described and set opposite their names, to have such lands included in the City of Mankato, Blue Earth County, Minnesota, to-wit:

North Star Concrete Company Poplar & Mound Streets Mankato, Minnesota 56001

The South four hundred and fifty (450) feet of the West four hundred and eighty (480) feet of the South half of the Southeast Quarter of the Southwest Quarter ( S½ SE¼ SW¼) of Section nine (9), Township one hundred and eight (108) Range twenty-six (26), together with the right-of-way of T.H. #14 adjoining.

Landkamer Brothers Company Walnut and Second Streets Mankato, Minnesota 56001 The East two hundred and fifty (250) feet of the West seven hundred and thirty (730) feet of the South four hundred and fifty (450) feet of the South half of the Southeast Quarter of the Southwest Quarter (5½ SE¼ SW¼) of Section nine (9), Township one hundred and eight (108), Range twenty-six (26).

II.

The quantity of land embraced within the foregoing description is unplatted and does not exceed 200 acres and is not within the corporate limits of any city or village and is contiguous to and abutting upon a portion of the easterly boundary of the City of Mankato, Minnesota, an incorporated city, having a population of not less than 10,000 nor more than 30,000, pursuant to the last census. That it appears from the records of the Clerk of the City of Mankato, Minnesota, that copies of the petition asking for annexation were filed with the Minnesota Municipal Commission, the Mankato Township Town Board, and the Blue Earth County Board, and that the thirty day period as provided for by Section 414.03 of M.S.A., Subdivision 2, and the Rules of the Municipal Commission, having been duly waived by the Mankato Township Board, Blue Earth County Board, and that no objections to said annexation were submitted.

The City Council of Mankato, Minnesota, hereby determines that the annexation of the above described property will be to the best interests of the municipality and of the land affected and that the above described tracts or parcels of land are so conditioned as properly to be subjected to city government and are hereby annexed to and declared to be an addition to the City of Mankato, as effectually as if it had originally been a part thereof and the corporate limits of the City of Mankato, Minnesota are hereby extended to include said property.

The City Clerk is hereby directed to file certified copies of this ordinance with the Minnesota Municipal Commission, the County Auditor, and the Secretary of State, and this ordinance takes effect ten (10) days after its passage and publication and upon the filing of certified copies as herein described.
