Ordinance No. 424

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF MOORHEAD TO INCLUDE CERTAIN UNINCORPORATED PROPERTY OWNED BY AND ABUTTING UPON THE LIMITS OF THE CITY

WHEREAS, the territory described below is not presently within the corporate limits of any incorporated city, village, or borough; and

WHEREAS, this territory abuts upon the corporate limits of the tity of Moorhead at the northern boundary thereof and is deemed to be urban in character; and

WHEREAS, this territory is owned in fee by the City of Moorhead; BE IT ORDAINED BY THE CITY OF MOORHEAD AS FOLLOWS:

<u>Section 1</u>. <u>Territory Annexed</u>. The corporate limits of the City of Moorhead are hereby extended to include the unplatted pro-' perty described as follows now owned by the City:

Beginning at the point of intersection of the center-line of 15th Avenue North and 10th Street North; thence in a northerly direction parallel to the centerline of County Highway No. 3 a distance of 1000 feet; thence in a westerly direction parallel to the centerline of said 15th Avenue North a distance of 620 feet; thence in a southerly direction parallel to the centerline of said Clay County Highway No. 3 a distance of 385 feet; thence in a southwesterly direction 257.50 feet more or less to a point of intersection with the north boundary line of the existing sewage plant site; thence in an easterly direction along said north boundary of the existing sewage plant site to the northeast corner of said sewage plant site; thence in a southerly direction along the east boundary line of the existing sewage plant site a distance of 365 feet to the point of intersection with the centerline of said 15th Avenue North; thence in a easterly direction along the centerline of said 15th Avenue North a distance of 245.16 feet more or less to the point of beginning and there terminating. Said tract of land being located in the south half of Section 32, Township 140 North, Range 48 West, Clay County, Minnesota.

<u>Section 2</u>. <u>Filing</u>. The City Clerk is directed to file certified copies of this ordinance with the Secretary of State, the County Auditor of Clay County and the Minnesota Municipal Commission.

<u>Section 3.</u> <u>Effective Date of Annexation</u>. This ordinance takes effect upon its passage and publication and the filing of certified copies as directed in section 2. Adopted by the City Council of Moorhead, Minnesota. (APPROVED)
