ORDINANCE NO. 83

An Ordinance Annexing a Certain Tract of Land to the Village of Lamberton, Redwood County, Minnesota

The Village Council of the Village of Lamberton, Minnesota, do ordain as follows:

Section 1. Annexation.

The following tract of land lying and being in the County of Redwood and State of Minnesota, and abutting upon the corporate limits of the gaid Village of Lamberton, particularly described as follows, to-wit:

Commercing at a point Three Hundred Ninety Six (396) feet East of the Northwest corner of the Northeast Quarter of the Northwest Quarter (NEX-NNA) of Section Number Twenty Six (26) in Township One Hundred Mine (109), Range Number Thirty Seven (37) thence South parallel with the West line of said Northeast Quarter of the Northwest Quarter (NEX-MA) of said Section Twenty Six (26), a distance of Three Bundred Thirteen (313) feet, thence West parallel with the North line of said Northeast Quarter of the Northwest Quarter (NEX-NAX) of said Section Number Twenty Six (26), a distance of Three Hundred Ninety Six (396) feet to the West line of said Northeast Quarter of the Northwest Quarter (NEX-NWA), thence South along said West line, a distance of Two Hundred Twenty (220) feet. thence East parallel with the North line of said Northeast Quarter of the Northwest Quarter (NEZ-NW) of said Section Twenty Six (26), One Thousand, Three Hundred Forty Six (1,346) feet, thence North Barallel to the said West line of said Northeast Quarter of the Northwest Quarter (NEX-NN/s), a distance of Five Bundred, Thirty Three (533) feet to the North line of said Section Number Twenty Six (26), thence West along the said North line of said Section Twenty Sin (26) to the place of beginning.

is hereby annexed to and made a part of the Village of Lamberton, Redwood County Minresora, as fully and for all purposes as if originally a part thereof.

Section 2. Liability for Debts.

The aforesaid tract of land shall be liable for all general bonded indebredness of the said Village of Lamberton in the same manner as all other lands within said Village of Lamberton.

Section 3. Taxation

The aforesaid tract of land shall be subject to and liable for all general and special taxes assessed and levied in said Village of Lamberton in the year of 1960 and thereafter.

Section 4. Effective Date.

This ordinance shall be in full force and effect from and after its passage and publication.
