## ORDINANCE NO. 461

AN ORDINANCE ANNUAING LAND TO THE CITY OF WHITE BEAR LAKE, MINNESOTA

WHEREAS, the owners of all of the land hereinafter described, which is unplatted and does not exceed 200 acres, have petitioned the City Council of the City of White Bear Lake, Minnesota, to have said land annexed to the City of White Bear Lake, Minnesota; and

WHEREAS, a copy of said Pctition was filed with the required governmental units and the Minnesota Municipal Commission, and

WHEREAS, no written objections to such amexation have been submitted to the Minnesota Municipal Commission or the City of White Bear Lake within the 20 day period required by Minnesota Statutes, and

WHEREAS, the City Council feels that such annexation will be to the best interest of the City of White Bear Lake and of the territory affected,

NOW THEREFORE, The Council of the City of White Bear Lake, Minnesota, does ordain:

1. That the following described land situated in Ramsey County, Minnesote, to-wit:

The South Two Mundred Sixty-four feet of the West One Eundred Sixty-five feet of the Northeast one-quarter (NE 1/4) of the Northeast one-quarter (NE 1/4) of Section Fifteen (15), Township Thirty (39), Range Twenty-two (22) of that part lying north of Ninth Street, but subject to the rights of the public in Ninth Street

The NE 1/4 of the NE 1/4 of Section 15, Township 30, Range 22, except the West 165' of the South 264' and except the East 265' of the South 400' subject to existing railroad right of way and subject to Ninth Street.

be and the same is hereby annexed to the City of White Bear Lake, Minnesota.
