

An Ordinance Annexing Certain Lands to the Village of Karlstad, Kittson County, Minnesota.

The Village Council of the village of Karlstad, Kittson County, Minnesota, do ordain as follows:

Section 1. That the following described lands, namely,

Lots three (3) and four (4) of the Southwest quarter (SW1-4) of Section nineteen (19), Township one hundred fifty-nine (159), Range forty-five (45), containing sixty-five and thirty-two hundredths (65 32/100) acres,

abutting upon the incorporated village of Karlstad, be and the same are hereby annexed to make a part of and included within such village as effectually as if it had originally been a part thereof.
