AN ORDINANCE ANNEXING CERTAIN LANDS TO
THE VILLAGE OF LE ROY, MINNESOTA

The Village Council of the Village of LeRoy, Minnesota,
do ordain:

WHEREAS, all the owners of the premises hereinafter described
have petitioned the Village Council that said premises be annexed
to the corporate limits of the Village of LeRoy, Minnesota, and
said premises being contiguous to and adjoining the Village of
LeRoy and subject to incorporation within the corporate limits
of LeRoy, Minnesota, by petition to the governing body of the
Village of LeRoy;

And due notice having been given to the Township of LeRoy,
Commissioners of the County of Mower and the Municipal Commission
for the State of Minnesota;

The land hereinafter described shall be added to and
incorporated within the corporate limits of the Village of
LeRoy, and said Village Council does hereby declare said premises
hereinafter described to be incorporated within and to be a part
of the Village of LeRoy, described as follows:

All that part of Out Lot 26, in the Southeast Quarter of
Section 28, Township 101 North, Range 14 West, lying North
of Highway 56 as extended on and running in a northwesterly
direction from the Westerly end of Main Street of LeRoy
Station; and that part of Out Lot 20, in said Southeast
Quarter of Section 28, together with all abutting roads
and rights-of-way.
