AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF WINDOM IN MINN. APPROXIMATELY 2.7 ACRES OF LAND ADJACENT THE CITY

WHEREAS, a petition dated Nov. 12, 1968, requesting annexation of land hereinafter described was presented to the Council; and

WHEREAS, the quantity of land embraced within the area described in the petition and bounded as described is 2.7 acres of land, no part of which is included within or abuts upon the boundary of any incorporated city, village or borough; and

WHEREAS, the petition was signed by all of the property owners; and

WHEREAS, copies of the said petition have been duly filed with the Minnesota Municipal Commission, the town board of Great Bend Township and the County Board of Cottonwood County, being the town and county in which all of the land proposed to be annexed is located, and written objection to the annexation have not been submitted to the City by the Town Board or the County Board; and

WHEREAS, the land described in the petition abuts upon the city limits at the Westerly boundary thereof.

BE IT ORDAINED BY THE CITY OF WINDOM, MINN. AS FOLLOWS TO WIT:

SECTION 1: The City Council hereby determines (1) that the annexation will be to the best interest of the City and of the territory affected; (2) that the territory described herein abuts upon the city limits and is about to become urban in character; and (3) that none of the territory is now included within the limits of any other city, village or borough.

SECTION 2: The corporate limits of the city are hereby extended to include the unplatted land hereinafter described and the same is hereby annexed to and included within the city as effectually as if it had originally been a part thereof.

SECTION 3: The description of the land located in the Township of Great Bend in Cottonwood County, Minnesota, which is hereby annexed is described as follows to-wit:

A tract of land in the Southeast Quarter of the Northwest Quarter (SE $\frac{1}{4}$  NW $\frac{1}{4}$ ) of Section Twenty-six (26), Township One Hundred Five (105) North, Range Thirty-six (36) West of the Fifth Principal Meridian in Great Bend Township, Cottonwood County, Minnesota, bounded by the following described lines:

Beginning at the intersection of the East line of the Northwest Quarter (NW $\frac{1}{4}$ ) of said Section 26, with the existing Centerline of River Road; thence South along the East line of the NW $\frac{1}{4}$  of said Section 26 a distance of 256 feet more or less, to the center of the stream called the Outlet of Cottonwood Lake; thence Southerly and Westerly along the center of said stream a distance of 150 feet, more or less; thence Northerly and Westerly along the center of said stream a distance of 531 feet, more or less; thence North 48°44'30" East, a distance of 200 feet, more or less, to the centerline of said River Road; thence South 41°15'30" East, along the Centerline of said River Road a distance of 353.04 feet, to the point of beginning.
