1.33 AN ORDINANCE ANNEXING CONTIGUOUS TERRITORY TO THE CITY OF PIPESTONE

The City Council of the City of Pipestone do ordain as follows:

Section 1. The land described as the South four hundred sixteen feet (416.0') of the west five hundred forty-seven and eight/tenths (547.8') of the Northeast Quarter (NE $\frac{1}{4}$) Section Eighteen (Sec.18), Township One Hundred Six north (T106N), Range Forty-Five West (R45W) of the Fifth Principal Meridian (5th P.M.) in the County of Pipestone, State of Minnesota, except the Chicago, Rock Island and Pacific Railroad right of way, containing five acres (5.00ac.); now owned by the Pipestone Area Development Corporation, and being contiguous to and abutting on the corporated limits of said city, is hereby declared to be a part of the City of Pipestone.

Section 2. This ordinance shall take effect and be in force from and after its passage and publication.
