AN ORDINANCE
ANNEXING PROPERTY
TO THE VILLAGE OF

PRIOR LAKE, MINNESOTA WHEREAS, St. Paul Luther-an Church Of Prior Lake, A Minnesota Corporation, being the sole owner of the follow-

All that part of the Northwest Quarter of the Southeast Quarter (NW 4 of SEAL Section 36, Township 115, Range 22; Scott County Minnesota; lying southeast and described as a new laid out, centaining 3261 acres more of less; hast petitioned the Village Council of the Village of Prior Lake, Minnesota, annexed to the Village of Prior Lake, Minnesota; and Whilereas, The Village

ment, NOW THEREFORE, The Vallage Council of the Village of Pictor Lake, Minnesota ordains;

That the following described property. Tying in Scott County, Minnesota, to-wit;
All that part of the Northwest Quarter of the North-east Quarter (NW14 of SE14), Section 36, Town-ship 115, Range 22, Scott County, Minnesota, lying southerly and easterly of State Highway No. 13, as now laid out, containing 32.31 agrees more or less. 32.31 acres more or less; which lies outside the corporate limits of the Village of Prior Lake, Minnesota, be, and the same is hereby annexed to the Village of Prior Lake, Minnesota, and said property is hereby declared an addition to said Village.

Upon the effective date of this ordinance, such property shall become a part of said Village as effectively as if it had been originally a part thereof.

This ordinance shall take effect and be in force from and test and be in force from and aften its passage and publication, and after filing as hereinafter set forth. The Village Council is hereby instructed to cause accritified copies of this ordinance to be filed in the office of the Register of Deeds, Scott County, Minnesota, the office of the County Auditor, Scott County, Minnesota, the office of the Secresota, the office of the Secretary of the Municipal Commission, State of Minnesota, and, in the office of the Secretary of State of the State

of Minnesota.
