ORDINANCE NUMBER 1.7011

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE VILLAGE OF MADELIA TO INCLUDE CERTAIN UNINCORPORATED PLATTED LAND ADJUTING UPON THE VILLAGE LIMITS

WHEREAS, a certain petition dated August 26, 1968, requesting annexation of the territory hereinafter described was duly presented to the Council on the 26th day of August, 1968.

AND WHEREAS, the quantity of land embraced within the area described in the petition abounded as described is less than one-half acre of platted land, no part of which is included in the limits of an unincorporated city, village or borough;

AND WHEREAS, the petition was signed by all the owners;

AND WHEREAS, no objections to the annexation have been received from the Town Board, the County Board or the governing body of any municipality whose boundaries abut upon the boundaries of the land to be annexed;

AND WHEREAS, the land described in the petition abuts upon the Village at the Northeast boundary thereof;

The Council of the Village of Madelia, Minnesota, ORDAINS:

Section 1. The Village Council hereby determines that the annexation will be to the best interests of the Village and to the territory affected. is urban or suburban in character;

C. That none of said territory is now included within the limits of any city, village or borough.

Section 2. The corporate limits of the Village are hereby extended to include the platted land described as follows and the same is hereby annexed to include within the village as effectually as if it had originally been a part thereof:

The North 90 feet of the South 230 feet of the West 160 feet of Outlot "B" of Farnsworth's Second Addition to the Village of Madelia, Watonwan County, Minnesota, including that portion of Drew Avenue N. E. abutting on the west of said property.



ORDINANCE NUMBER 1.7011

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE VILLAGE OF

ABUTTING UPON THE VILLAGE LIMITS

WHEREAS, a certain petition dated August 26, 1968, requesting annexation of the territory hereinafter described was duly presented to the Council on the 26th day of August, 1968.

AND WHEREAS, the quantity of land embraced within the area described in the petition abounded as described is less than one-half acre of platted land, no part of which is included within the limits of an incorporated city, village or borough;

AND WHEREAS, the petition was signed by all the owners;

AND WHEREAS, no objections to the annexation have been received from the Town Board, the County Board or the governing body of any municipality whose boundaries abut upon the boundaries of the land to be annexed;

AND WHEREAS, the land described in the petition abuts upon the Village at the Northeast boundary thereof;

The council of the Village of Madelia, Minnesota, ORDAINS:

Section 1.

A. The Village Council hereby determines that the annexation will be to the best interests of the Village and to the territory affected.

B. That the territory described herein abuts upon the Village limits and is urban or suburban in character;

C. That none of said territory is now included within the limits of any city, village or borough.

Section 2. The corporate limits of the Village are hereby extended to include the platted land described as follows and the same is hereby annexed to include within the village as effectually as if it had originally been a part thereof:

The North 95 feet of the South 230 feet of the West 160 feet of Outlot "B" of Farnsworth's Second Addition to the Village of Madelia, Watonwan County, Minnesota, including that portion of Drew Avenue N. E. abutting on the west of said property.

Section 3. The Village Clerk is hereby directed to file certified copies of this ordinance with the Minnesota Municipal Commission, the Secretary of State and the County Auditor.

Section. This ordinance takes effect upon its passage and publication and filing of certified copies as directed in Section 3.
