Ordinance No. 37/

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF MONTEVIDEO TO INCLUDE CERTAIN LANDS ABUTTING UPON THE CITY LIMITS

WHEREAS, a certain petition requesting annexation of the territory hereinafter described was duly presented to the council on the 5th day of September, 1968; and

WHEREAS, the quantity of land embraced within the area described in the petition and bounded as described is 0.964 acres, no part of which is included within the limits of an incorporated city, village or borough; and

WHEREAS, the petition was signed by Theodore Skramstad, the owner of the premises therein described; and

WHEREAS, no objections to the annexation have been received from the town board, the county board or the governing body of any municipality whose boundaries abut upon the boundaries of the land to be annexed; and

WHEREAS, the land described in the petition abuts upon the city limits at the easterly boundary thereof;

The City of Montevideo does Ordain:

<u>Section 1.</u> The City Council hereby determines (1) that the annexation will be to the best interests of the city and of the territory affected; (2) that the territory described herein abuts upon the City limits and is urban or suburban in character; and (3) that none of said territory is now included within the limits of any city, village or borough.

Section 2. Territory Annexed. The corporate limits of the City are hereby extended to include the land described as follows and the same is hereby annexed to and included within the City as effectually as if it had originally been a part thereof:

The North 140 Feet of the Easterly 300 Feet of Sublot Six (6) in Odd Fellows Subdivision into Sublots One (1) through Six (6) in the East Half (E_2) of Section Seven (7), Town-ship One Hundred Seventeen (117) North, Range Forty (40) West, containing 0.964 acres.

<u>Section 3. Filing.</u> The City Clerk is hereby directed to file certified copies of this ordinance with the Minnesota Municipal Commission, the Secretary of State, and the County Auditor.

<u>Section 4.</u> <u>Effective Date.</u> This ordinance takes effect upon its passage and publication and the filing of the certified copies as directed in Section 3.
