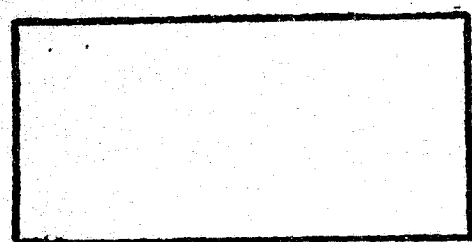

AN ORDINANCE ANNEXING CERTAIN LAND TO THE CITY OF NORTHFIELD
THE CITY OF NORTHFIELD DOES ORDAIN:

Section 1. A petition by all the owners to annex to the City of Northfield, the 88.36 acre tract of real estate situated in Rice County, State of Minnesota, described as follows to-wit:

Tract I: The South Half (SH) of the Northeast Quarter (NE) of the Northeast Quarter (NE) of Section Thirty-five (35), Township One Hundred Twelve (112) North, Range Twenty (20) West, Rice County, Minnesota,

Tract II: The Northeast Quarter (NE) of the Southwest Quarter (SW) of the Northeast Quarter (NE) of Section Thirty-five (35), Township One Hundred Twelve (112) North, Range Twenty (20) West, Rice County, Minnesota,

Tract III: The South Half (SH) of the Southwest Quarter (SW) of the Northeast Quarter (NE) of Section Thirty-five (35), Township One Hundred Twelve (112) North, Range Twenty (20) West, Rice County, Minnesota,

Tract IV: The Southeast Quarter (SE) of the Northeast Quarter (NE) of Section Thirty-five (35), Township One Hundred Twelve (112) North, Range Twenty (20) West, excepting therefrom the following:

a. Beginning at the souther line of State Aid Road 97, 643 feet North of the Southeast corner of the Northeast Quarter (NE) of Section Thirty-five (35), Township One Hundred Twelve (112), Range Twenty (20); thence running North 170 feet; thence running West 301 feet; thence running South 170 feet; thence running East 301 feet to the place of beginning;

b. Beginning at a point 563 feet North of the Southeast corner of the Northeast Quarter (NE) of Section Thirty-five (35), Township One Hundred Twelve (112) North, Range Twenty (20) West, Rice County, State of Minnesota; running thence North 85 feet; thence West 238 feet; thence South 85 feet; thence East 238 feet to the place of beginning.

has been received; that said aforescribed real estate abuts on the City limits of the City of Northfield.

Section 2. That copies of said petition were duly served upon the Municipal Commission, the Township of Bridgewater, Rice County, State of Minnesota, and the County Board of the County of Rice, Minnesota, and over thirty days have elapsed since service was made with no objections being filed to the annexation.
