ORDINANCE NO. 256

AN ORDINANCE FOR THE ANNEXATION OF CERTAIN LAND CONTIGUOUS TO AND ABUTTING UPON THE CITY LIMITS OF THE CITY OF HUTCHINSON, MCLEOD COUNTY, HUTCHINSON, MINNESOTA

The City Council of the City of Hutchinson ordains.

The undersigned, Gladys C. Peterson and Edwin H. Peterson, her husband, are the owners of all of the real estate described below and said petitioners do hereby petition the City Council of the City of Hutchinson to annex the real estate hereinafter described to the City of Hutchinson and said petitioners represent that the real estate herein described abutts on real estate that is already in the City of Hutchinson, McLeod County, Minnesota, and that it would be to the best interests of the City of Hutchinson and the owners of said real estate for said real estate to be annexed to the City of Hutchinson.

The real estate for which this Petition is signed and submitted is located in McLeod County, Minnesota, and is described as follows:
