ORDINANCE NO. 256

AN ORDINANCE FOR THE ANNEXATION OF CERTAIN LAND CONTIGUOUS  
TO AND ABUTTING UPON THE CITY LIMITS OF THE CITY OF  
HUTCHINSON, MCLEOD COUNTY, HUTCHINSON, MINNESOTA

The City Council of the City of Hutchinson ordains:

The undersigned, Gladys C. Peterson and Edwin H. Peterson, her husband, are the owners of all of the real estate described below and said petitioners do hereby petition the City Council of the City of Hutchinson to annex the real estate hereinafter described to the City of Hutchinson and said petitioners represent that the real estate herein described abutts on real estate that is already in the City of Hutchinson, McLeod County, Minnesota, and that it would be to the best interests of the City of Hutchinson and the owners of said real estate for said real estate to be annexed to the City of Hutchinson.

The real estate for which this Petition is signed and submitted is located in McLeod County, Minnesota, and is described as follows:

The Easterly 142 feet of the real estate described as follows:

Commencing at a point where the West line of the Townsite of the City of Hutchinson, North Half, intersects the South line of the Northeast Quarter of the Southeast Quarter of Section 36, Township 117, Range 30; thence North along the said West townsite line a distance of approximately 170 feet to the center line of Minnesota Trunk Highway No. 7, thence Westerly along the center line of said Trunk Highway No. 7 to a point on the South line of the Northeast Quarter of the Southeast Quarter of said Section 36 lying a distance of 750 feet West of the place of beginning; thence East to the place of beginning, containing 1 acre, more or less, all in the Northeast Quarter of the Southeast Quarter of Section 36, Township 117, Range 30.

Alderman Gruett seconded the motion of Alderman Johnson to introduce Ordinance No. 256 for its third and final reading. Upon roll call all members present voted in favor of Ordinance No. 256 and it was declared passed on its third and final reading by Mayor Rolfe.

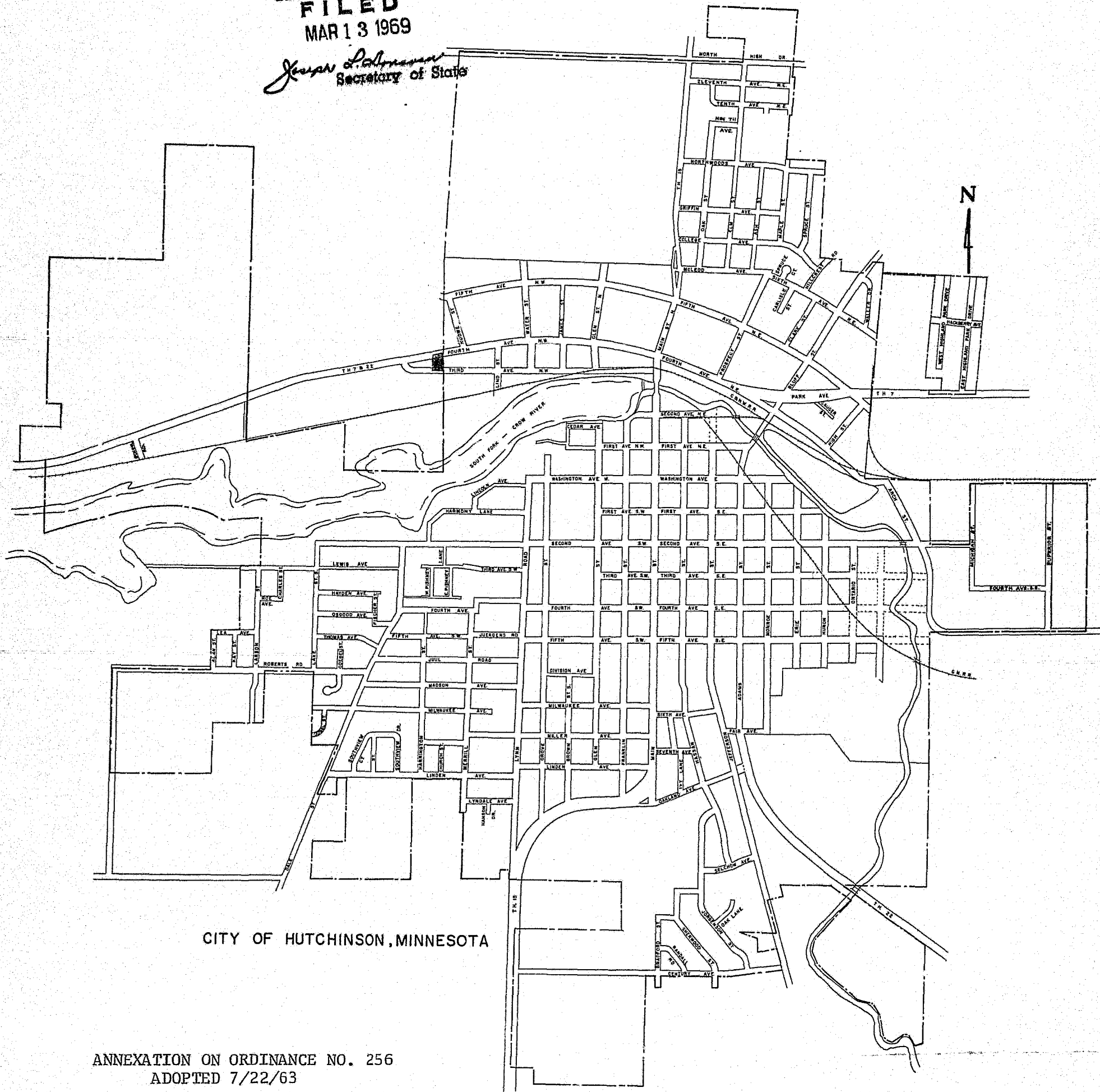
