

VILLAGE OF NEW LONDON

ORDINANCE NO. 57

AN ORDINANCE ANNEXING CERTAIN LANDS IN SECTION FIFTEEN (15), TOWNSHIP ONE HUNDRED TWENTY ONE (121), NORTH, RANGE THIRTY FOUR (34) WEST

The Village Council of New London ordains:

That certain lands adjacent to the Village of New London are hereby annexed.

Section 1. ORIGINATION AND PROCEDURE: The owners of certain unincorporated lands contiguous to the Village of New London requested annexation pursuant to Section 414.09, Subdivision 2, fourth paragraph of Minnesota Statutes, which permits a majority of owners of platted land, or unplatted lands not exceeding two hundred (200) acres, to petition the Village Council of New London to have such land included within the municipality. Such a Petition was filed with the Village Council of New London on the 25th day of October, 1968, and thereafter copies of said Petition were filed with the Minnesota Municipal Commission, New London Town Board and Kandiyohi County Board. There being no written objections to the annexation from either the Minnesota Municipal Commission, New London Town Board or the Kandiyohi County Board filed with the Minnesota Municipal Commission and the Village of New London, a hearing before the Village Council of New London was held on the 6th day of January, 1969, after at least thirty (30) days posted notice and three (3) weeks published notice, at which time the proposed annexation was deemed to be in the best interests of the municipality and of the territory being annexed. This Annexation proceeding shall be deemed final upon the filing of a copy of this Ordinance with the Minnesota Municipal Commission, the Kandiyohi County Auditor and the Secretary of State for the State of Minnesota.

Section 2. DESCRIPTION: Lands subject to this annexation are in the Township of New London, County of Kandiyohi, State of Minnesota, described as follows, to-wit:

All that land and property in Section Fifteen (15), Township One Hundred Twenty One (121) North, Range Thirty Four (34) West, lying south of center line of County Highway No. 40 and bounded on the East by the Great Northern Railway right-of-way, and bounded on the West and South by center line of State Highway No. 9.

Section 3. EFFECTIVE DATE: This Ordinance is deemed to be in full force and effect from and after its date of publication.
