

ORDINANCE NO. _____

AN ORDINANCE DECLARING CERTAIN PLATTED LAND TO BE
ANNEXED TO THE CITY OF NORTH MANKATO, MINNESOTA.

The Common Council of the City of North Mankato, Minnesota, does
ordain as follows:

(1) The following tract of land lying adjacent to the City of
North Mankato and being in the County of Nicollet and described as
follows:

A parcel of land in the NW $\frac{1}{4}$ of the NW $\frac{1}{4}$ of Sec. 12, T. 108 N.,
R. 27 W. of the fifth principle meridian in Belgrade Township,
Nicollet County, Minnesota, more particularly described as
follows:

Beginning at the SW corner of Lot 12, Crestview Subdivision
of Blocks 1, 2, 3, 4, 5 and 6 in Crestview Addition to the City
of North Mankato, Minnesota; thence N. 89°05' West, 350 feet
along the North line of Lots 10, 9, 8 and 7 in said Crestview
Subdivision; thence North 155 feet to the beginning of a 23°55'34"
curve right; thence Northeasterly 177.39 feet, along said curve
to a point on a line parallel to and 320 feet North of the first
described course; thence South 89°05' East, 287.75 feet to the
Northwest corner of Lot 15 in said Crestview Subdivision; thence
South 320 feet along the West lines of Lots 15, 14, 13 and 12
in said Crestview Subdivision to the point of beginning, the
same being approximately 2.5 acres, together with any and all
streets, highways and other public right of ways within and
adjacent to said described land,

is hereby annexed and declared to be a part of the City of North Mankato
and to be included in the corporate limits thereof.

(2) This Ordinance shall take effect from and after its date of
passage and publication.
