ORDINANCE NO. 44

AN ORDINANCE ANNEXING CERTAIN LANDS INTO THE INCORPORATED LIMITS OF THE VILLAGE OF WATERTOWN

The Village Council of the Village of Watertown, Carver County, Minnesota, ordains:

That the following described premises lying adjacent to and abutting the present village limits of the Village of Watertown and situate in the County of Carver and State of Minnesota, to-wit:

Out Lots 33-34-35-36-37-38-39-40-41-42-43-44-45-46-47 and 48, Village of Watertown, according to the plat thereof on file and of record in the office of the Register of Deeds, Carver County, Minnesota.

The above situated upon the Southwest Quarter (SW $\frac{1}{4}$) of Section 4, Township 117, Range 25.

be and the same hereby is annexed to the Village of Watertown pursuant to Minnesota Statutes Section 414.03, Subd. 7, and the corporate limit line is hereby extended to encompass and embrace all of said premises.

Be it further ordained, that this Ordinance shall be in full force and effect upon the filing of a certified copy thereof with the Municipal Commission of the State of Minnesota, the Carver County Auditor, and the Secretary of State.
