ORDINANCE NO. 48

AN ORDINANCE ANNEKING CERTAIN LANDS INTO THE
INCORPORATED LIMITS OF THE VILLAGE OF WATERTOWN,
MINNESOTA

WHEREAS, a certain Petition, dated the 20th day of July, 1966,
and requesting annexation to the Village of Watertown of certain territory
described below, was duly presented to the Village Council of the Village
of Watertown, on the 20th day of July, 1966, pursuant to Minnesota Statutes,
Section 414.03; and

WHEREAS, the Village Council finds that said Petition was signed
by all of the owners of said lands and is suitable and proper in all respects;
and

WHEREAS, copies of said Petition were duly forwarded to the Clerk
of the Town Board of the Township of Watertown, the County Auditor of the
County of Carver, and the Municipal Commission of the State of Minnesota,
as required by law, and that more than thirty days have elapsed since said
copies were sent to and received by said parties.

THE VILLAGE COUNCIL OF THE VILLAGE OF WATERTOWN, CARVER
COUNTY, MINNESOTA, ORDAINS:

Section. 1. Declaration. It is hereby determined that a copy of said
Petition was duly mailed, as required by law, to the Town Board of the Town
of Watertown, the Carver County Board, and the Municipal Commission of the
State of Minnesota, and that no objection to the proposed annexation has been
made by any of said parties or filed with the Village Council; that the territory
described below abuts upon the present corporate limits of the Village of
Watertown; that said lands do not exceed 200 acres in area; that said lands are
not now included in any other municipality; that said lands are conditioned as

properly to be subjected to municipal government; and that the annexation of said lands would be to the best interests of the Village of Watertown and the territory to be annexed.

Section 2. Territory Annexed. The corporate limits of the Village of Watertown are hereby extended to encompass and embrace all of the territory described as follows, to-wit:

Outlots Sixty-six (66) and Sixty-seven (67), according to to the Plat of the Village of Watertown on file and of record in the office of the Register of Deeds in and for the County of Carver and State of Minnesota.

Section 3. Filing. The Village Clerk is hereby directed to file certified copies of this Ordinance with the Municipal Commission of the State of Minnesota, the Secretary of State, and the Auditor of Carver County, as required by law.

Section 4. Effective Date of Annexation. Annexation shall be deemed final upon the filing of this Ordinance as set forth in Section 3 and publication of same as required by law.

ORDINANCE NO. 56

AN ORDINANCE AMENDING ORDINANCE No. 48, ENTITLED
"AN ORDINANCE ANNEXING CERTAIN LANDS INTO THE VILLAGE
OF WATERTOWN, MINNESOTA"

The Village Council of the Village of Watertown, Carver County, Minnesota,
does hereby Ordain:

Section 1. That Section 2 of Ordinance No. 48 of the Village of Water-
town, which Ordinance was duly adopted on the 6th day of December, 1966,
and being entitled "An Ordinance Annexing Certain Lands into the Village
of Watertown, Minnesota" be and the same is hereby amended to read as fol-
lows, to-wit:

Section 2. Territory Annexed. The corporate limits of the Village
of Watertown are hereby extended to encompass and embrace all of the
territory described as follows, to-wit:

Outlots Sixty-six (66) and Sixty-seven (67) and that part of
Jefferson Street adjacent to and abutting said Outlots, accord-
ing to the Plat of the Village of Watertown on file and of re-
cord in the office of the Register of Deeds in and for Carver
County, Minnesota.

Situated upon the NW $\frac{1}{4}$ of Section 8, Township 117, Range 25.

Section 2. Filing. The Village Clerk is hereby directed to file certi-
fied copies of this Ordinance with the Municipal Commission of the State of
Minnesota, The Secretary of State, and The Auditor of Carver County, as re-
quired by law.

Section 3. Effective Date. This Ordinance shall be in effect upon
the filing of this Ordinance as set forth in Section 2 and upon publication
as required by law.
