ORDINANCE NO. 57

AN ORDINANCE AMENDING ORDINANCE No. 50, ENTITLED
"AN ORDINANCE ANNEXING CERTAIN LANDS INTO THE IN-
CORPORATED LIMITS OF THE VILLAGE OF WATERTOWN,
MINNESOTA"

The Village Council of the Village of Watertown, Carver County, Minnesota,
does hereby Ordain:

Section 1. That Section 2 of Ordinance No. 50 of the Village of Water-
town, which Ordinance was duly adopted on the 21st day of February, 1967,
and being entitled "An Ordinance Annexing Certain Lands into the Incorpora-
ted Limits of the Village of Watertown, Minnesota" be and the same is hereby
amended to read as follows, to-wit:

Section 2. Territory Annexed. The corporate limits of the Village
of Watertown are hereby extended to encompass and embrace all of the
territory described as follows, to-wit:

Outlots Sixty-four (64) and Sixty-five (65); that part of
Jefferson Street adjacent to and abutting said Outlots; and
the Southwesterly 33 feet of Stevens Street, adjacent to and
abutting said Outlots, according to the Plat of the Village
of Watertown on file and of record in the office of the Regis-
ter of Deeds in and for the County of Carver and State of
Minnesota.

The above situated upon the Southeast Quarter (SE $\frac{1}{4}$) of
Section 5, Township 117, Range 25.

Section 2. Filing. The Village Clerk is hereby directed to file certified
copies of this Ordinance with the Municipal Commission of the State of Minne-
sota, the Secretary of State, and the Auditor of Carver County, as required
by law.

Section 3. Effective Date. This Ordinance shall be in effect upon
the filing of this Ordinance as set forth in Section 2 and upon publication
as required by law.
