ORDINANCE NO. 58

AN ORDINANCE ANNEXING CERTAIN LANDS INTO THE INCORPORATED LIMITS OF THE VILLAGE OF WATERTOWN, MINNESOTA

Whereas, The Village of Watertown owns certain land adjacent to and abutting the present corporate limits of the Village of Watertown; and

Whereas, It is determined that it would be for the best interest of the Village of Watertown if such land were annexed to the Village of Watertown;

THE VILLAGE COUNCIL OF THE VILLAGE OF WATERTOWN, CARVER COUNTY, MINNESOTA, ORDAINS:

Section 1. Declaration. It is hereby determined that the territory described below is presently owned in fee by the Village of Watertown; that said territory is adjacent to and abuts upon the present corporate limits of the Village of Watertown; that said lands are not now included in any other municipality; that said lands are conditioned as properly to be subject to municipal government; and that an annexation of said lands would be to the best interest of the Village of Watertown and the territory to be annexed.

Section 2. Territory Annexed. The corporate limits of the Village of Watertown are hereby extended to encompass and embrace all of the territory described as follows, to-wit:

Outlots Fifty-nine (59), Sixty (60), Sixty-one (61), Sixty-two (62) and Sixty-three (63); that part of Jefferson Street adjacent to and abutting said Outlots 59, 61 and 62; the Northeastly 33 feet of Jefferson Street adjacent to and abutting said Outlots 62 and 63; and the Southeastly 33 feet of White Street, adjacent to and abutting said Outlots 59 and 60; according to the Plat of the Village of Watertown on file and of record in the office of the Register of Deeds in and for the County of Carver and the State of Minnesota.

The above situated upon the Southeast Quarter (SE $\frac{1}{4}$) of Section 5, Township 117, Range 25.

Outlots One Hundred (100), One Hundred One (101) and One Hundred Two (102), according to the plat of the Village of Watertown on file and of record in the office of the Register of Deeds in and for Carver County, Minnesota.

The above situated upon the Northwest Quarter (NW $\frac{1}{4}$) of Section 8, Township 117, Range 25.

Section 3. Filing. The Village Clerk is hereby directed to file certified copies of this Ordinance with the Municipal Commission of the State of Minnesota, the Secretary of State and the Auditor of Carver County, as required by law.
