ORDINANCE 110.58

AN ORDIHANCE ANNEXING CERTAIN LANDS INTO THE INCORPORATED LIMITS OF THE VILLAGE OF WATERTOWN, MINNESOTA

Whereas. The Village of Watertown owns certain land adjacent to and abutting the present corporate limits of the Village of Watertown; and

Whereas, It is determined that it would be for the best interest of the Village of Watertown:

THE VILLAGE COUNCIL OF THE VILLAGE OF WATERTOWN, CARVER COUNTY, MINNE-SOTA, ORDAINS:

Section 1. <u>Declaration</u>. It is horeby determined that the territory described below is presently exmed in fee by the Village of Matertown; that said territory is adjacent to and abutes upon the present corporate limits of the Village of Matertown; that said lands are not now included in any other municipalty; that said lands are conditioned as properly to be subject to municipal government; and that an annexation of said lands would be to the best interest of the Village of Matertown and the territory to be annexed.

Section 2. <u>Territory Annexed</u>. The corporate limits of the Village of Watertown are hereby extended to encompass and embrace all of the territory described as follows, to-wit:

Outlots Fifty-nine (59), Sixty (60), Sixty-one (61), Sixty-two (62) and Sixty-three (63); that part of Jefferson Street adjacent to and abutting said Outlots 59. 51 and 62; the Northeasterly 23 feet of Jefferson Street adjacent to and abutting said Outlots 62 and 63; and the Southeasterly 33 feet of White Street, adjacent to and abutting said Outlots 59 and 60; according to the Plat of the Villago of Watertown on file and of record in the office of the Register of Deeds in and for the County of Carver and Sx State of Minnesota.

The above situated upon the Southeast Quarter (SE%) of Section 5, Township 117, Range 25.

Outlots One Hundred (100), One Hundred One (101) and One Hundred Two (102), according to the plat of the Village of Natertown on file and of record in the office of the Register of Beeds in and for Carver County, Minnesote.

The above situated upon the Hortmass Quarter (NHA) of Section 8, Township 117, Range 25.

Section 3. Filing. The Village Clerk is hereby directed to file certified copies of this Ordinance with the Hunicipal Commission of the State of Hinnesete, the Secretary of State and the Auditor of Corver County, as required by law.

Section 4. <u>Effective Date of Annexation</u>. Annexation shall be deemed final upon the filing of this Ordinance as set forth in Section 3 and publication of same as required by law.
