



ORDINANCE NO. 193

An Ordinance annexing a part of the East half (E 1/2) of the Southeast quarter (SE 1/4) of Section Twenty (20), Township Thirty (30) North, Range Twenty-one (21) West and Lots 1, 2, 3 and 4, Block 1, Forest Heights 2nd Addition, in Washington County, to the Village of Mahtomedi, Minnesota.

THE VILLAGE COUNCIL OF THE VILLAGE OF MAHTOMEDI DO ORDAIN AS FOLLOWS:

Section 1. That pursuant to those certain petitions signed by all of the owners of the lands hereinafter described in Washington County, Minnesota, containing less than two hundred acres, abutting on the Easterly border of the Village of Mahtomedi, requesting the annexation of said lands to said Village, said petitions having been duly filed with the Clerk of said Village, and it appearing that such annexation will be to the best interests of the Village and of the territories affected, the Village boundaries of the Village of Mahtomedi are hereby extended to include said lands described as follows:

All that part of the East One-half (E 1/2) of the Southeast Quarter (SE 1/4) of Section 20, Township 30 North, Range 21 West, described as follows:

Commencing at the Southeast corner of Lot 4, East Shore Garden Lots, thence running Easterly on the extended South line of said Lot 4 and parallel with the South line of said tract to the East line thereof; thence Northerly along the East line thereof to a point due East of the Northeast corner of said Lot 4, of East Shore Garden Lots; thence Westerly on a line parallel with the South line of said tract to the Northeast corner of said Lot 4 of East Shore Garden Lots aforesaid; thence Southerly along the East line of said Lot 4 of East Shore Garden Lots aforesaid to the place of beginning; excepting therefrom the West 25 feet and the Northerly 135 feet;

and

Commencing at the Southwest corner of Lot 4, Block 1, Forest Heights 2nd Addition, thence running Northerly along the West line of said Lot 4 a distance of 178 feet to a point on the center line of Dahlia Street; thence running Easterly along the center line of Dahlia Street a distance of 215 feet to a point on the center line of Warner Avenue; thence running Southerly along the center line of Warner Avenue a distance of 178 feet to a point on the center line of Warner Avenue; thence running Westerly and parallel with the center line of Dahlia Street a distance of 215 feet to the Southwest corner of Lot 4, Block 1, Forest Heights 2nd Addition, the point of beginning.


