ORDINANCE NO. 1919 By _____

An Ordinance Extending The Corporate Limits of the City of Albert Lea to include certain unincorporated property Owned By and Abutting Upon The Limits of the City

Introduced by Councilman Robert Quackenbush

WHEREAS, the territory described below is not presently within the corporate limits of any incorporated city, village, or borough; and

WHEREAS, this territory abuts upon the corporate limits of the City at the Northerly boundary thereof and is deemed to be urban in character; and

WHEREAS, this territory is owned in fee by the City;

THE CITY COUNCIL OF ALBERT LEA DOES ORDAIN:

Sec. 1. Territory Annexed. The corporate limits of the City of Albert Lea are hereby extended to include the unplatted property described as follows now owned by the City:

Beginning at the NE Corner of Sec. ~~32~~ Township 102 Range 21 W thence west to the NW Corner of the NE $\frac{1}{4}$ of NE $\frac{1}{4}$ Section 32, thence south to the SW Corner of the NE $\frac{1}{4}$ of NE $\frac{1}{4}$ Section 32, thence west to the NW Corner of the SE $\frac{1}{4}$ of the NW $\frac{1}{4}$ of Section 32, thence S to the SW Corner of the SE $\frac{1}{4}$ of the NW $\frac{1}{4}$ of Section 32 thence W to a point 33' East of the SW Corner of the NW $\frac{1}{4}$ Sec. 32, thence South 420.32' thence East 252'; thence south 305.68' thence East to the West line of the NE $\frac{1}{4}$ of the SW $\frac{1}{4}$ of Sec. 32 thence South 594' to the SW Corner of the NE $\frac{1}{4}$ of the SW $\frac{1}{4}$ of Section 32, thence East to a point 945' West of the NE Corner of the SW $\frac{1}{4}$ of the SW $\frac{1}{4}$ of Section 33, thence South and East in a direct line to a point 670' West of the SE Corner of the SW $\frac{1}{4}$ of the SW $\frac{1}{4}$ of Section 33, thence East 670' to the SE Corner of the SW $\frac{1}{4}$ of SW $\frac{1}{4}$ of Section 33, thence north to the SE Corner of the SW $\frac{1}{4}$ of NW $\frac{1}{4}$ of Section 33, thence west 16.5', thence north parallel to and 16.5' west of the East 1 mile of the SW $\frac{1}{4}$ of the NW $\frac{1}{4}$ of Section 33, to the North line of the SW $\frac{1}{4}$ of the NW $\frac{1}{4}$ of Section 33, thence West along said north line to a point 670' East of the SW Corner of the NW $\frac{1}{4}$ of the NW $\frac{1}{4}$ of Section 33, thence North and west to a point on the North line of Section 33 and 410' east of the NE corner of Section 33, thence West 410' to the point of beginning. Lying in Sections 32 & 33, Township 102, Range 21 and containing 420 acres.

Sec. 2. Filing. The City Clerk is directed to file certified copies of this ordinance with the Secretary of State, the County Auditor of the county in which the property is located, and the Minnesota Municipal Commission.

Sec. 3. Effective Date of Annexation. This ordinance takes effect upon its passage and publication and the filing of certified copies as directed in Section 2.

Sec. 4. The above area to be included in Ward 1 of the City of Albert Lea and zoned as P-Public Facilities District.
