

Ordinance No. 499

An Ordinance Extending the Corporate Limits of the City of Willmar, a Municipal Corporation of the State of Minnesota, to Include Certain Land Not Exceeding 200 Acres.

WHEREAS, The following described land is completely surrounded by the City of Willmar, Minnesota, and whereas the said property abuts upon the City and is so conditioned as to be property subject to city government and since annexation thereof will be to the best interests of the City of Willmar and of the territory to be annexed,

NOW THEREFORE, Be It Ordained by the City Council of the City of Willmar, as follows:

Section 1. Annexation. The following described property is hereby annexed and included within the City of Willmar, Minnesota, as effectually as if it had originally been a part thereof:

All that part of the Northwest Quarter of Section 23, Township 119, Range 35 West, described by metes and bounds as follows: Commencing at a point on the North line of said Section 23 660 feet West of the Northeast corner of the Northwest Quarter of Section 23 of said township and range, thence running South and parallel to the East line of the Northwest Quarter of Section 23 a distance of 655 feet, thence East and parallel with the North line of said Northwest Quarter a distance of 660 feet to a point on the East line of said Northwest Quarter; thence North on and along said East line of said Northwest Quarter to the Northeast corner of the Northwest Quarter of Section 23; thence West on and along the North line of said Northwest Quarter 660 feet to the point of beginning, containing 9.9 acres more or less and lying within the County of Kandiyohi, State of Minnesota.

Section 2. Zoning. The property annexed herein shall be zoned F.A.M. RESIDENCE

Section 3. Effective Date. This Ordinance shall be final and shall take effect and be in full force from and after filing a certified copy hereof with the Minnesota Municipal Commission, the County Auditor of the County of Kandiyohi, Minnesota, and the Secretary of State of the State of Minnesota, and from and after its passage and publication.
