ORDINANCE NO. 90

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE VILLAGE OF LINDSTROM, MINNESOTA, TO INCLUDE CERTAIN UNINCORPORATED UNPLATTED LAND NOT EXCEPTING 200 ACRES IN AREA ABUTTING UPON THE VILLAGE LIMITS.

WHEREAS, A CERTAIN PETITION DATED September 15, 1966, requesting annexation of certain territory hereinafter described was duly presented to the Council on the 13 day of 1966, and

WHEREAS, the quantity of land embraced within the area described in the petition and bounded as described is approximately acres of unplatted land, no part of which is included within the limits of an incorporated city, village or borough; and

WHEREAS, the petition was signed by all of the owners of the land proposed to be annexed as hereinafter described, and

WHEREAS, the land described in the petition abuts upon the Village limits at the northerly boundary thereof; and

WHEREAS, copies of said Petition have been filed with the Municipal Commission, the Town Board of the Town of Chisago Lake, and the Chisago County Board of County Commissioners, said Town and County being the Town and County in which all of the land proposed to be annexed is located, and

WHEREAS, THE BOUNDARIES of no other municipality abut upon the boundaries of the land to be so annexed, and

WHEREAS, no written objections to said annexation have been submitted to the Municipal Commission or the Village of Lindstrom by the Chisago Lake Town Board or the Chisago County Board of Commissioner within thirty (30) days after said filing and the time allowed presuant

to law, and

WHEREAS, no petition for incorporation or annexation is pending before the Municipal Commission including all or any part of the land proposed to be annexed and herein described;

The Council of the Village of Mndstrom, Minnesota, ordains:

Section 1. The Village Council hereby determines (1) that the ammenation will be to the best interests of the Village and of the territory affected; (2) that the territory described herein abuts upon the Village limits and is urban in character; and (3) that none of said territory is now included within the limits of any incorporated city, village or borough, is unplatted and does not exceed 200 acres in area.

Section 2. Ferritory annexed. The corporate limits of the Village are hereby extended to include the unplatted land described follows and the same is hereby annexed to and included within the Village as effectually as if it had originally been a part thereof:

That part of Government Lot Three (3), Section Thirty three (33), Township Thirty-four (34) North, Range Twenty (20) West, described as follows:

Commencing at the Northeast corner of Lot Eight (8), Block Two (2), Lantz's Addition to Lindstrom, as per plat thereof on file and of record in the Office of the Register of Deeds in and for Chisago County, Minnesota; thence North 3° 20' West on the extension of the easterly line of said Block Two (2) 50.05 feet, to the North line of Margaret Street as per said recorded plat; thence North 90 40' West along said westerly line of Oak Street (aka C.S.A.H. #20). 408.15 feet to the point of beginning; thence continua on the same course (N 90 40' West) 64.2 feet; thence Worth 17° 27' West 339.1 feet; thence running South 720 53' West to the shore of North Lindstrom Lake; thence Southerly along said shore line to the point of intersection thereof with a line which bears North 89° 32' 30" West from the point of beginning; thence South 89° 32' 30" East 407.29 feet, more or less, to the point of beginning.

Subject to a 60-foot easement road, the center line of which is described as follows: Beginning at the

point on the South line of the above described tract which point is 122.66 feet westerly (at a bearing of North 890 32' 30" West) from the southeast corner of said above described tract; thence North 0° 41' 10" West 380 feet to the North line of said tract and their terminating.

The Village Clerk is hereby directed to file certified copies of this ordinance with the Minnesota Municipal Commission, the Secretary of State, and the County Auditor of Chisago County, Minnesota.

Section 4. Effective Date. This ordinance takes effect upon its passage and publication and the filing of certified copies as directed in Section 3. .

ANEXIMENT TO ORDINANCE NO. 90

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE VELLAGE OF LINDSTROM, MINNESOTA, TO INCLUDE CERTAIN UNINCORPORATED UNPLATTED LAND NOT EXCEEDING 200 ACRES IN AREA ABUTTING UPON THE VILLAGE LIMITS

Section 2 of Ordinance No. 90 is hereby amended to read as follows:

"Section 2. Territory annexed. The corporate limits of the Village are hereby extended to include the unplatted land described as follows and the same is hereby annexed to and included within the Village as effectually as if it had exiginally been a part thereof:

That part of Government Lot Seven (7) section Twenty-cight (26), Township Thirty-Four (34), Range Twenty (20) West, described as follows:

Sommencing at the Northeast corner of Let Eight (8), Block Two (2), Lantz's Addition to Lindstrom, as per plat thereof on file and of record in the Office of the Register of Deeds in and for Chisago County, Minnesota; thence North 3° 20' West on the extension of the easterly line of said Block Two (2) 50.05 feet, to the North line of Margaret Street as per said recorded plat; thence North 9° 40' West along said Westerly line of Oak Street (aka C.S.A.H. #20), AUS.15 feet to the point of beginning; thence continuing on the same course (N 90° 40' West) 64.2 feet; thence North 17° 27' West 339.1 feet; thence running South 72° 53' West to the shore of North Lindstrom Lake; thence Southerly along said shore line to the point of intersection thereof with a line which bears North 39° 32' 30" West from the Point of beignning; thence South 89° 32' 30" East 407.29 feet, more or less, to the point of beginning.

Subject to a 60-foot casement road, the center line of which is described as follows: Beginning at the point on the South line of the above described tract which point is 122.66 feet westerly (at a bearing of Morth 69 32' 30" West) from the Southeast corner of said above described tract; thence North 0° 41'10" West 380 feet to the North line of said tract and there terminating."

This Amendment to Ordinance No. 90 takes effect upon the passage and publication and the filing of certified copies of directed in Section 3 of said Ordinance No. 10.
