Dear Sir:-

The enclosed Notice refers to an Unsurveyed Island in Burntside Lake, St. Louis County, Minnesota, lying very close to Lot 4 of sec. 21, and Lot 4 of Sec. 22, Twp. 63 North, Range 13 West, a large island containing 103.50 acres, owned by Alice Hall Gregory, wife of James C. Gregory, the applicant for the survey.

The island, which has already been scripped, has a solid rock, foundation of from 4 to 9 feet above high water mark, with a few Jack Pine and Spruce trees on it, and has not been formed by accretion or lowering of the lake, and has been in existence, according to all signs of nature, ever since this country was created by the great laws of the universe.

Mrs. Gregory desires to obtain title to this little dot of an island as a matter of protection.


Sir:-

You will please take notice that the undersigned has an application pending in the General Land Office at Washington, D.C., for the survey of a certain island in Burnside Lake, St. Louis County, Minnesota, more particularly described as follows:

An unsurveyed island located in the Southeast portion of Section Twenty-one (21), Township Sixty-three (63) North, Range Thirteen (13) West, containing approximately Thirty Hundredths (0.30) acre, more or less, lying about 500 feet north and 15 degrees west from N.C. (on south shore) north of the Section Corner of Sections 21, 22, 27 and 28, and about 100 feet east from the southeast shoreline of Lot Four (4) of Section Twenty-one (21), Township Sixty-three (63) North, Range Thirteen (13) West of Fourth P. M.

You are allowed thirty (30) days from the receipt of this notice within which to file in said General Land Office any papers you may wish to submit tending to show cause, if any there be, why said island should not be surveyed and disposed of as public land of the United States.
