ORDINANCE NO. 429

**AN ORDINANCE ANNEXING
CERTAIN PROPERTY ABUT-
TING THE CITY OF ANOKA,
TO THE CITY OF ANOKA.**

The Commission of the City of Anoka do ordain as follows:

Section 1.

Pursuant to a proper and sufficient petition by Rudy I. Peterson, Era M. Smith, Henry J. Brom, Katherine E. Brom and the Estate of F. J. Hays, the owners of a tract, piece and parcel of land abutting the City of Anoka, Minnesota, and described as follows, to-wit:

That part of Section Thirty-five (35), Township Thirty-two (32) North, Range Twenty-five (25) West, being bounded and described as follows; the variation being Eight Degrees, Forty-five Minutes (8° 45') East;

Commencing at the center of said Section Thirty-five (35); thence East along the quarter line Twenty-Eight and Twenty-five Hundredths (28.25) chains; thence South Fifteen and Twenty-two hundredths (15.22) chains to the Northerly boundary line of the right of way of the Northern Pacific Railway Company; thence Northwesterly on said boundary line Thirty-one and Three Hundredths (31.03) chains to the North and South quarter line; thence North on said quarter line Two and Forty-two Hundredths (2.42) chains

to the place of beginning and containing Twenty-four and Ninety-one Hundredths (24.91) acres of land.

Now known as Lot Two (2), Auditor's Subdivision Number Twenty-eight (28), Anoka County. Subject to easements of record to the Anoka Electric Cooperative and the Northwestern Bell Telephone Company.

And,

The East One-half (E½) of the West One-half (W½) of the Northeast Quarter (NE¼) of Section Thirty-five (35), Township Thirty-two (32), North of Range Twenty-five (25), except that part thereof lying North of the center line of County Aid Road No. Fifty-seven (57), formerly County Aid Road No. Twenty-five (25), subject to road easement over the North Thirty-five (35) feet thereof. Subject to easement of record running in favor of Anoka Electric Cooperative, and,

That part of the East ten (10) rods of Northwest Quarter (NW¼), Section Thirty-five (35), Township Thirty-two (32), Range Twenty-five (25), Anoka County, Minnesota, lying Southerly of County Road No. Fifty-seven (57), as same is now laid out and traveled. Also, that part of West One-half (W½) of West One-half (W½) of Northeast Quarter (NE¼), Section Thirty-five (35),

Township Thirty-two (32), Range Twenty-five (25), Anoka County, Minnesota, lying Southerly of County Road No. Fifty-seven (57) as the same is now laid out and traveled, and,

Lot One (1), Auditor's Subdivision No. Twenty-eight (28), Anoka County, Minnesota;

to have said territory annexed to the City of Anoka, the Commission having determined that the land described in said petition abuts on the City of Anoka, is not included in any other municipality, does not exceed 200 acres in area, and that the annexation to the City of Anoka will be to the best interests of the City of Anoka and of the territory described in the petition, said tract, piece and parcel of land is hereby declared to be annexed to and to be an addition to the City of Anoka.

Section 2.

This Ordinance shall be in full force and effect thirty (30) days from date of publication.
