

ORDINANCE EXTENDING THE CORPORATE LIMITS
OF THE CITY OF MANKATO TO INCLUDE CERTAIN
UNPLATTED LANDS NOT EXCEEDING TWO HUNDRED
ACRES, PURSUANT TO M.S.A., SECTION 414.03,
SUBDIVISION 2, AND ALL LAWS AMENDATORY AND
SUPPLEMENTARY THERETO, AND IN ACCORDANCE
WITH THE RULES OF PROCEDURE OF THE MUNICI-
PAL COMMISSION.

The City of Mankato, Minnesota, does ordain:

I.

A Petition has been filed with the City Clerk of the City of Mankato, Minnesota, by Thomas P. Coughlan, Helen Coughlan, Daniel J. Coughlan, Dorothy Coughlan, Robert M. Coughlan, Jeanette Coughlan, John J. Howard, Patricia Howard, John C. Pohl, Pauline Pohl, Maynard H. Selsvold, Clarene A. Selsvold, Martha C. Oftedahl and Farman Oftedahl, as owners of the following described property, to have such land included in the City of Mankato, Blue Earth County, Minnesota, to-wit:

Commencing at a point on the West line of Section 20, Township 108 North, Range 26 West, said West line of Section 20 being the centerline of County State Aid Highway No. 8, 330.00 feet North of the Southwest corner of said Section 20; thence North, along said West line, 660.00 feet; thence East, parallel and 990.00 feet North of the South line of said Section 20, 2,654.91 feet to the West line of the Southwest Quarter of the Southeast Quarter of said Section 20; thence North, along the West line of the Southwest Quarter of the Southeast Quarter of said Section 20, 50.00 feet; thence South 89 degrees 43 minutes East, 20.00 feet; thence South, parallel to the West line of the Southwest Quarter of the Southeast Quarter of said Section 20, 50.00 feet; thence South 89 degrees 43 minutes East, 1,221.20 feet to the centerline of a Township Road, said Road known as "Pohl Road"; thence South 6 degrees 30 minutes West, along said road centerline, 50.00 feet; thence South 10 degrees 13 minutes West, along said road centerline, 50.00 feet; thence South 11 degrees 01 minutes West, along said road centerline, 571.30 feet; thence North 89 degrees 42 minutes West, 1101.20 feet to the West line of the Southwest Quarter of the Southeast Quarter of said Section 20, said point being 330.00 feet North of the South quarter corner of said Section 20; thence West, parallel and 330.00 feet North of the South line of said Section 20, 2,650.97 feet to the point of beginning. Said tract containing 57.8052 acres, all in Blue Earth County, Minnesota.

II.

The quantity of land embraced within the foregoing description is unplatted and does not exceed 200 acres and is not within the corporate limits of any city or village and is contiguous to and abutting

upon a portion of the easterly boundary of the City of Mankato, Minnesota, an incorporated city, having a population of not less than 10,000 nor more than 30,000, pursuant to the last census. That it appears from the records of the Clerk of the City of Mankato, Minnesota, that copies of the petition asking for annexation were filed with the Minnesota Municipal Commission, the Mankato Township Town Board, and the Blue Earth County Board, and that more than thirty days have elapsed since said filing and that no objections to said annexation were submitted.

III.

The City Council of Mankato, Minnesota, hereby determines that the annexation of the above described property will be to the best interests of the municipality and of the land affected and that the above described tracts and parcels of land are so conditioned as properly to be subjected to city government and are hereby annexed to and declared to be an addition to the City of Mankato, as effectually as if they had originally been a part thereof and the corporate limits of the City of Mankato, Minnesota, are hereby extended to include said property.

The City Clerk is hereby directed to file certified copies of this ordinance with the Minnesota Municipal Commission, the County Auditor, and the Secretary of State, and this ordinance takes effect ten (10) days after its passage and publication and upon the filing of certified copies, as herein described.
