AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF CROOKSTON TO INCLUDE CERTAIN UNINCORPORATED TERRITORY BORDERED ON THREE SIDES BY LAND WITHIN THE CITY LIMITS AND ABUTTING THEREON.

WHEREAS certain territory described below is not presently included within the corporate limits of any incorporated city, village or borough; and

WHEREAS this territory is seventy-five percent bordered on three sides by lands already included within the corporate limits of said City of Crookston and is deemed to be urban in character;

NOW THEREFORE, Be It Ordained by the City of Crookston as follows:

Section 1. Territory Annexed: The corporate limits of the City of Crookston, Minnesota, are hereby extended to include the platted and unplatted territory described as follows; which territory now is and has heretofore been seventy-five % bordered on three sides by territory already included within the City limits:

Parcel No. A.: -----Commencing at a point on the Northerly line of the Northeast quarter of the Northeast quarter ($NE\frac{1}{4} NE\frac{1}{4}$), of Section 25, Township 150, North, of Range 47, West of the 5th Principal Meridian (in Polk County, Minnesota), which point is $9\frac{1}{2}$ rods Easterly of the Northwest corner of said Northeast quarter of the Northeast quarter ($NE\frac{1}{4} NE\frac{1}{4}$); thence Southerly at right angles and parallel with the Westerly line of said Northeast quarter of the Northeast quarter ($NE\frac{1}{4} NE\frac{1}{4}$), to a point on the Southerly line of said Northeast quarter of the Northeast quarter ($NE\frac{1}{4} NE\frac{1}{4}$); thence Westerly along said Southerly line a distance of 8 rods to a point; thence Northerly at right angles and parallel with said Westerly line of said Northeast quarter of the Northeast quarter ($NE\frac{1}{4} NE\frac{1}{4}$) to the Northerly line of said Northeast quarter of the Northeast quarter ($NE\frac{1}{4} NE\frac{1}{4}$); thence Easterly along said Northerly line a distance of 8 rods to the point of commencement -----;

Parcel No. B.: -----A tract of land (in Polk County, Minnesota) bounded as follows: Commencing at a point on the North and South quarter line of Section 25, Township 150 North, of Range 47, West of the 5th Principal Meridian, twelve hundred feet (1200') North of the center of said Section 25; thence South along the said North and South quarter line to a point five hundred sixty-one feet (561') North of the center of said Section 25; thence Easterly and parallel to the South line of the Northerly quarter line of said Section 25 to the North and South $1/16$ line of the Northeast quarter of said Section 25; thence North along the said North and South $1/16$ line to a point three hundred feet (300') South of the center of the Northeast quarter of said Section 25; thence Westerly and parallel to the East and West $1/16$ line in the Northeast quarter of said Section 25 to a point two hundred eleven and $3/10$ feet (211.3') East of the North and South quarter line of said Section 25; thence Northerly and parallel to the North and South quarter line a distance of three hundred feet (300') to the East and West $1/16$ line of the Northeast quarter of said Section 25; thence West along the said $1/16$ line two hundred eleven and $3/10$ feet (211.3') to the West $1/16$ corner of the Northeast quarter of said Section 25; thence South along the said North and South quarter line one hundred and twenty feet (120') more or less, to the point of beginning -----;

Section 2. Filing: The City Clerk is directed to file certified copies of this Ordinance with the Secretary of State, the County Auditor of the County of Polk and the Minnesota Municipal Commission.

Section 3. Effective Date of Annexation: This Ordinance takes effect upon its passage and publication and the filing of certified copies as directed in Section 2. and pursuant to the Municipal Charter.
