## ORDINANCE NO. 322

AN ORDINANCE FOR THE ANNEXATION OF CERTAIN LANDS INTO THE CITY OF ORTONVILLE, MINNESOTA.

The City Council of the City of Ortonville, Minnesota, does ordain:

Section 1. That the following described premises abutting the municipal corporate limits of the City of Ortonville, Minnesota, be and are hereby annexed and brought within the corporate limits of the City of Ortonville, Minnesota, to-wit:

The Southerly Three Hundred Feet (Sly 300') of that part of the East Half of the Southeast Quarter ( $E\frac{1}{2}SE\frac{1}{4}$ ) of Section Nine (9), Township One Hundred Twenty-one North (121N), Range Forty-six West (46W) lying immediately northerly of and adjacent to Hilltop Addition to the City of Ortonville.

Section 2. This Ordinance shall be in force and effect from and after its passage and publication according to law.
