ORDINANCE NO. 1487

AN ORDINANCE Annexing to the City of Rochester, Minnesota, Certain Unplatted Land not Exceeding Two Hundred Acres in Area, Being in the Northwest Quarter of Section Four, Township One Hundred Six North, Range Fourteen West, Olmsted County, Minnesota. The Common Council of the City of Rochester do ordain: Section 1. A petition has been filled with the Common Council of the City of Rochester, signed by all the owners of the land described herein, requesting the Common Council to annex said land to the City of Rochester, The land described in Sochester Township, Olmsted County, Minnesota, and is described as follows:

That tract of land in the Northwest Quarter (NWW) of Section Four (4), Township One Hundred Six (106) North, Range Fourteen (14) West, described by metes and bounds as follows:

Beginning at the Southwest corner of Lot Twenty-seven (27). Block One (1). Country Club Manor First Addition, thence South along the Easterly right of way line of 36th Avenue Northwest a distance of 189.00 feet to the Northerly right of way line of County State Aid Highway No. 34, thence Northeasterly along said right of way line a distance of 129.87 feet, thence Northerly a distance of 152.03 feet to the Southeast corner of said Lot Twenty-seven (27). thence Westerly a distance of 125.17 feet to the point of bealanting including the East half of 36th Avenue Northwest and the North half of County State Aid Highway No. 34.

Said petition has also been filed with the Town Board of the Township of Rochester, with the County Board of the County of Olmsted and with the Municipal Commission of the State of Minnesota and more than thirty (30) days have elapsed since said petition was filed with said Town Board and County Board and no objections to annexation of the above described land included in said petition is approximately .49 acres.
