ORDINANCE # 348

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF LITCHFIELD, MINNESOTA TO INCLUDE CERTAIN UNINCORPORATED UNPLATTED LAND NOT EXCEEDING 200 ACRES IN AREA ADJACENT UPON THE CITY LIMITS.

WHEREAS, a certain petition, dated October 18, 1968, requesting annexation of the territory hereinafter described, was duly presented to the Council on the 21st day of November, 1968, and

WHEREAS, the quantity of land embraced within the area described in the petition, and bounded as described is approximately Two and one-quarter ($2\frac{1}{4}$) acres of unplatte land, no part of which is included within the limits of an incorporated city, village, or borough; and

WHEREAS, the petition was signed by all the owners of said land; and

WHEREAS, no objections to the annexation have been received from the town board, the county board, or the governing body of any municipality whose boundaries abut upon the boundaries of the land to be annexed; and

WHEREAS, the land described in the petition abuts upon the city limits at the East boundary thereof;

The Council of the City of Litchfield, Minnesota ordains:

Section 1. The City Council hereby determines (1) that the annexation will be to the best interests of the city and of the territory affected (2) that the territory described herein abuts upon the city limits and is urban or suburban in character; and (3) that none of said territory is now included within the limits of any city, village or borough.

Section 2. Territory Annexed. The corporate limits of the city are hereby extended to include the unplatte land described as follows and the same is hereby annexed to and included within the city as effectually as if had originally been a part thereof; being approximately Two and one-quarter ($2\frac{1}{4}$) acres of land described as follows:

The westerly 550 feet of the West Half of the Southeast Quarter ($\frac{1}{4}$ of the SE $\frac{1}{4}$), of Section Twelve (12), Township One Hundred-nineteen North (119N), Range Thirty-one West (31W) excepting the southerly 1142.7 foot and also excepting a part of the West Half of the Southeast Quarter ($\frac{1}{4}$ of the SE $\frac{1}{4}$), of Section Twelve (12), Township One Hundred-nineteen North (119N), Range Thirty-one West (31W)

described as follows, to-wit: Commencing at the Northwest (NW) corner of said West Half of the Southeast Quarter (W $\frac{1}{2}$ of the SE $\frac{1}{4}$), of Section Twelve (12), Township One Hundred-nineteen North (119N), Range Thirty-one West (31W) running thence South (S) along the East (E) line of Gorman Avenue a distance of 950 feet, thence due East (E) 550 feet, thence North (N) and parallel with the East (E) line of Gorman Avenue a distance of 950 feet, thence due West (W) 550 feet to the point of beginning.

All of the foregoing land being in Meeker County, Minnesota.

Section 3. Filing. The City Clerk is hereby directed to file certified copies of this ordinance with Minnesota Municipal Commission, the Secretary of State, and the County Auditor.

Section 4. Effective Date. This ordinance takes effect upon its passage and publication and filing of the certified copies as directed in Section 3.


