man pato a-1333 ORD. No. 68-105 ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF MANKATO TO INCLUDE CERTAIN UNPLATTED LANDS NOT EXCEEDING TWO HUNDRED ACRES, PURSUANT TO M.S.A. SECTION 414.03, SUBDIVISION 2, AND ALL LAWS AMENDATORY AND SUPPLEMENTARY THERETO, AND IN ACCORDANCE WITH THE RULES OF PROCEDURE OF THE MUNICIPAL COMMISSION. The City of Mankato, Minnesota, does ordain: A Petition has been filed with the City Clerk of the City of Mankato, Minnesota by Verne E. DeRemer and Gladys DeRemer, his wife, of the County of Blue Earth and State of Minnesota, as owners of the following described property, to have such land included in the City of Mankato, Blue Earth County, Minnesota, to-wit: West 264.00 feet of the North 558.80 feet of the Northwest Quarter (NW/4) of the Southwest Quarter (SW/4) of Section 16, Township 108 North, Range 26 II. The quantity of land embraced within the foregoing description is unplatted and does not exceed 200 acres and is not within the corporate limits of any city or village and is contiguous to and abutting upon a portion of the easterly boundary of the City of Mankato, Minnesota; and that said City of Mankato, Minnesota is an incorporated city, having a population of not less than 10,000 nor more than 30,000, pursuant to the last census.
