## CITY OF LITCHFIELD MINNESOTA

## ORDINANCE NUMBER 346

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF LITCH-FIELD, MINELSOTA TO INCLUDE CERTAIN UNITIONPORATED UNPLATTED LAND NOT EXCEEDING 200 ACRES IN AREA ABUTTING UPON THE CITY LIMITS.

WHEREAS, a cortain petition, dated May 9, 1968, requesting annexation of the territory hereinafter described, was duly presented to the Council on the 15th day of July, 1968, and

WHEREAS, the quantity of land embraced within the area described in the petition, and bounded as described is approximately Twelve and one-half (12%) acres of unplatted land, no part of which is included within the limits of an incorporated city, village, or borough; and

WHEREAS, the potition was signed by all the owners of said land; and WHEREAS, no objections to the annexation have been received from the town board, the county board, or the governing body of any municipality whose boundaries abut upon the boundaries of the land to be annexed; and

WHEREAS, the land described in the potition abuts upon the city limits at the East boundary thereof;

The Council of the City of Litchfield, Minnesota ordains:

Section 1. The City Council hereby determines (1) that the annexation will be to the best interests of the city and of the territory affected (2) that the territory described herein abuts upon the city limits and is urban or suburban in character; and (3) that none of said territory is now included within the limits of any city, village or borough.

Section. 2. Territory Annexed. The corporate limits of the city are hereby extended to include the unplatted land described as fillows and the same is hereby annexed to and included within the city as offectually as if had been originally been a part thereof; being approximately Twelve and one-half (12%) acres of land described as follows: A part of the West Half of the Southeast Quarter (W/2 of SE%) of Section Twelve (12), Township One Hundred Minoteen North (119-N), Range Thirty-one West (31-W), described as follows, to-wit: Commencing & the Northwest corner of said West Half of the Southeast Quarter (W/2 of SE%) of Section 12. Township 179 No. Range 31 W marries there for the Section 12.

East line of Gorman Avenue a distance of 950 feet, thence due East 550 feet, thence Worth and parallel with the East line of Gorman Avenue a distance of 950 feet, thence due West 550 feet to the point of beginning.

All of the foregoing land being in Mocker County, Minnesota.

Section 3. Filing. The City Clerk is hereby directed to file certified copies of this ordinance with Minnesota Municipal Commission, the Secretary of State and the County Auditor.

Bection 4. Effective Date. This ordinance takes effect upon its passage and publication and filing of the certified copies as directed in Section 3.
