ORDINANCE NO. 118

AN ORDINANCE ANNEXING CERTAIN LANDS INTO THE CORPORATE LIMITS OF THE CITY OF WACONIA

WHEREAS, a certain Petition, dated the 17th day of July, 1964, and requesting annexation to the City of Waconia of certain territory described below, was duly presented to and filed with the Common Council of the City of Waconia on the 19th day of July, 1964, pursuant to Minnesota Statutes, Section 414.03; and

WHEREAS, The Council finds that said Petition was signed by all of the owners of said land and was duly verified by them; and

WHEREAS, Copies of said Petition were filed with the Municipal Commission of the State of Minnesota, the town board of the Town of Waconia, Carver County, Minnesota, and the County Board of Carver County, Minnesota; and

WHEREAS, More than 30 days have elapsed since the dates of said filings and no objections has been made in writing, or otherwise, to the City of Waconia as to the annexation proposed by said petition:

THE COMMON COUNCIL OF THE CITY OF WACONIA, CARVER COUNTY, MINNESOTA, ORDAINS:

Section 1. Declaration. It is hereby determined that the territory described below abuts the present corporate limits of the City of Waconia; that said lands are unplatted and do not exceed 200 acres in area; that said lands are not now included in any other municipality; that said lands are conditioned as properly to be subjected to municipal government; and that annexations of said land would be to the best interests of the City of Waconia and of the territory to be annexed.

Section 2. Territory Annexed. The corporate limits of the City of Waconia are hereby extended to encompass and embrace all of the territory described as follows, to-wit:

That part of the South Half of the North Half of the Northeast Quarter of Section 23, Township 116, Range 25, Carver County, Minnesota, described as follows: Commencing at the intersection of the north line of said South Half of the North Half with the Southerly extension of the center line of said Maple Street; thence West along the north line of said South Half of the North Half 421.26 feet to the point of beginning of the tract to be described; thence continuing West along said north line 115 feet; thence South at right angles 150 feet; thence East at right angles 115 feet; thence North at right angles 150 feet to the point of beginning.

Section 3. Filing. The City Clerk is hereby directed to file certified copies of this Ordinance with the Municipal Commission of the State of Minnesota, the Secretary of State, and the Auditor of Carver County.
