A RESOLUTION OF THE VILLAGE COUNCIL OF THE VILLAGE OF  
DUNDAS, MINNESOTA, TO DECLARE THE RESULT OF AN ELECTION  
PROVING FOR THE REINCORPORATION OF SAID VILLAGE AND  
RELIQUISHING THE SPECIAL CHARTER UNDER WHICH SAID VILLAGE  
HAD HERETOFORE BEEN GOVERNED.

THE VILLAGE COUNCIL OF THE VILLAGE OF DUNDAS, MINNESOTA:-

Whereas, the Village of Dundas, Minnesota, has heretofore  
organized and has heretofore existed under and by virtue of  
a special charter granted to it by the Legislature of the  
State of Minnesota;

And, whereas, by resolution duly adopted by this Council  
on the 31st day of October, 1919, it was provided for the  
votation on the voters of the said Village of Dundas the  
proposition of reincorporating said village under the general  
laws of Minnesota, and the relinquishment of its said special  
charter;

And, whereas, one notice of said election was given as  
prescribed by law, and the said election was conducted in all  
things as required by Chapter 27 of the General Laws of Minnesota  
for the year 1919, and in conformity with the statute in such  
case made and provided;

And, whereas, a majority of the voters cast at said election  
favor the reincorporation of said village and the surrender of  
its special charter, the result being as follows, viz:-

For reincorporation 37 votes.  
Against reincorporation 11 votes.  
Total votes cast 48.

Therefore, the Village council of the Village does hereby  
declare that the majority of the voters cast at said election  
favored the reincorporation of said village and the relinquish-  
ment of its said special charter.

Passed, signed and approved this 9th, day of December, 1919.
