ORDINANCE NO. 357

AN ORDINANCE EXTENDING THE CORPORATE
LIMITS OF THE CITY OF WHITE BEAR LAKE TO
INCLUDE CERTAIN UNPLATTED LAND NOT
EXCEEDING TWO HUNDRED ACRES

Section 1. A petition has been filed with the governing body
of the City of White Bear Lake, Minnesota, by the sole owners of the
following described real estate to have such land included within the City
of White Bear Lake, Minnesota:

All of that part of Lot Twelve (12) Block Four (4)
Rearrangement of White Bear Park lying east of
Old Highway #61 and west of the new trunk Highway
#61 as said Highway is now located; and All that
part of Lot Thirteen (13) Block Four (4) Rearrange-
ment of White Bear Park lying east of Old Highway
#61 and west of the new trunk highway #61 as said
highway is now located, except that part conveyed
to Frank U. Macalus and Elizabeth J. Macalus by
deed dated June 23, 1955, and recorded in 1487.
Deeds 265 in the Office of the Register of Deeds of
Ramsey County.

Section 2. The quantity of land embraced within the foregoing
description, and bounded as described, is 2.67 acres.

Section 3. The City Council hereby determines (1) that the an-
nexation will be to the best interests of the City of White Bear Lake, Minnesota,
and of the territory affected; (2) that the territory described herein abuts upon
the City and is so conditioned as properly to be subjected to City government.

Section 4. Therefore, the City of White Bear Lake, Minnesota,
hereby ordains and declares that the property hereinbefore described by and
the same is hereby annexed to, and included in, the City of White Bear Lake,
Minnesota, as effectually as if it had originally been a part thereof.

Section 5. This ordinance shall be final and shall take effect and
be in force from and after filing a Certified Copy thereof with the Minnesota


