

ORDINANCE NO. 55

An ordinance annexing certain unplatted and platted lands to the Village of Atwater, Minnesota.

The Village Council of the Village of Atwater do ordain as follows:

Section 1:—That the following described platted and unplatted lands, to-wit:

All of Broberg's addition to the Village of Atwater, embracing Blocks One (1), Two (2), Three (3) and Four (4), according to the plat thereof on file and of record in the office of the Register of Deeds in and for said county, and

That part of the North Half ($N\frac{1}{2}$) of the South East Quarter ($SE\frac{1}{4}$) of Section Eleven (11) in Township One Hundred and Nineteen (119) of Range Thirty three (33), and described by metes and bounds as follows, to-wit:

Beginning at the southwest corner of Lot Seven (7) of Block Three (3) in Broberg's Addition to the Village of Atwater, running thence south to the south boundary line of the said North Half ($N\frac{1}{2}$) of the said South East Quarter ($SE\frac{1}{4}$), thence east on the said south boundary line to the east section line of said Section Eleven (11), thence north on said section line to the south boundary line of said Broberg's Addition, thence westerly on and along the south boundary line of said Broberg's Addition to the place of beginning, and

The North Forty four (44) rods of the West Half ($W\frac{1}{2}$) of the North West Quarter ($NW\frac{1}{4}$) of the South West Quarter ($SW\frac{1}{4}$) of section Twelve (12) in Township One Hundred and Nineteen (119) of Range (33), all of said lands being situated in the County of Kandiyohi and State of Minnesota, adjacent to and abutting upon the incorporated Village of Atwater, Kandiyohi County, Minnesota, and containing less than, and not exceeding Two Hundred (200) Acres, be and the same hereby are annexed to such Village as effectually as if they had been originally a part thereof.

Section 2:—That this ordinance shall take effect and be in force from and after its publication and the filing of a certified copy thereof with the Secretary of State.
