The Village of Sauk Rapids Ordains:


Ordinance No. 217, Section 15: 42 (1) c. and (4) c. is hereby amended to read as follows:

ORDINANCE NO. 217

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE VILLAGE OF SAUK RAPIDS TO INCLUDE CERTAIN PLATTED AND UNPLATTED LAND NOT EXCEEDING TWO HUNDRED ACRES.

Section 15: 42 (1) The governing body of the Village of Sauk Rapids, Minnesota, resolves to have the following land included within the Village of Sauk Rapids, Minnesota:

- a. All of that part of the Northwest Quarter of the Northwest Quarter (NW $\frac{1}{4}$  of NW $\frac{1}{4}$ ), Section Twenty-three (23), Township 36, Range 31, except for the portions of said tract which have been herein before annexed to the Village of Sauk Rapids.
- b. Larson's Parkland Addition, according to the plat and survey thereof.
- c. That part of the Southerly 432.00 feet of the Southwest Quarter of the Southwest Quarter (SW $\frac{1}{4}$  of SW $\frac{1}{4}$ ) of Section Fourteen (14), Township 36, Range 31.

(2) The quantity of land embraced within the foregoing descriptions is less than 200 acres.

(3) The Village Council hereby determines (1) that the annexation will be to the best interests of the Village of Sauk Rapids, Minnesota, and of the territory affected; (2) that the territory described herein abuts upon the Village and is so conditioned as properly to be subjected to Village government; (3) that petitions requesting such annexation have been received from all owners of said territory; (4) that said territory is presently within the limits of the town of Sauk Rapids, which town has consented in writing to said annexation; (5) that said territory is within Benton County, Minnesota and that the County Board of Said County was notified on July 17, 1968, of the proposed annexation, and that no objection has been received from Benton County although more than thirty days has elapsed, since such notice.

(4) Therefore, the Village of Sauk Rapids, Minnesota, hereby ordains and declares that the property herein before described by and the same is hereby annexed to, and included in, the Village of Sauk Rapids, Minnesota, as effectually as if it had originally been a part thereof and that upon annexation shall be zoned as follows:

- a. Larson's Parkland Addition, according to the plat and survey thereof will be zoned R-2.
- b. Lot's 1-3,, Block One (1), and Lots 1-6, Block two (2) , and Lot's 1-6 Block three (3), all of Block four (4), Lot's 1-7, Block Five (5), and Lot Two (2) Block Six (6), of North Elementary School Addition according to the proposed plat and survey thereof shall be zoned R-3.
- c. Lot one (1), Block six (6), of North Elementary School Addition according to the proposed plat and survey thereof shall be unclassified as school and educational properties.

(5) This ordinance shall be final and shall take effect and be in force from and after filing Certified copy thereof with the Minnesota Municipal Commission, the County Auditor and Secretary of State, from and after its passage and publication.

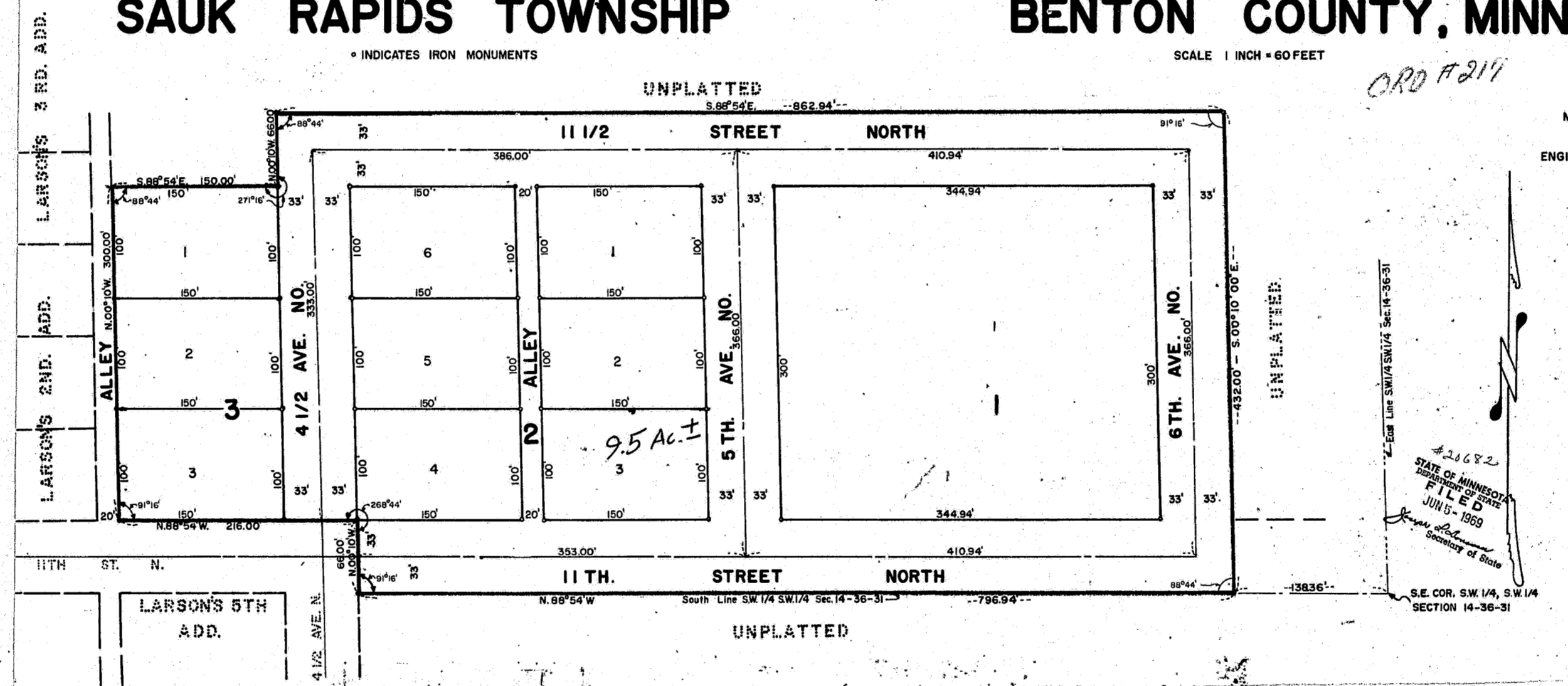
# LARSON'S PARKLAND ADDITION
