ORDINANCE NO. 596

AN ORDINANCE PROVIDING FOR THE ANNEXATION OF THE SOUTH ONE HUNDRED SIXTY FEET (160) OF LOT NINE (9), OF AUDITOR'S SUBDIVISION OF NORTH-WEST QUARTER (NW $\frac{1}{4}$) OF SECTION 20, TOWNSHIP 45, RANGE 30.

The Council of the City of Brainerd do ordain:

Section 1. That William Fitzsimmons and Rita C. Fitzsimmons, the fee owners of all the following described property, to-wit:

South One Hundred Sixty Feet (160) of Lot Nine (9), of Auditor's Subdivision of North-west Quarter (NW $\frac{1}{4}$) of Section 20, Township 45, Range 30,


filed a petition with the Council of the City of Brainerd on November 18, 1968 requesting that said realty be annexed to the City of Brainerd.



Section 4. This ordinance shall take effect and be in force one week from and after its publication.



of the following described property to the City of Brainerd:


