AN ORDINANCE TO AMEND ORDINANCE NO. 137
WHICH RELATES TO THE ANNEXATION TO THE
CITY OF JORDAN, SCOTT COUNTY, STATE OF
MINNESOTA, CERTAIN PROPERTY SITUATED IN
SECTION 30, SAND CREEK TOWNSHIP 114,
