ORDINANCE NO. 377

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF MONTEVIDEO TO INCLUDE CERTAIN LANDS SURROUNDED BY THE CITY

WHEREAS, certain territory described below is not presently included within the corporate limits of any incorporated city, village or borough; and

WHEREAS, this territory is completely surrounded on all sides by lands already included within the corporate limits of the City and is deemed to be urban in character;

The City of Montevideo does ordain:

Section 1. Territory Annexed. The corporate limits of the City of Montevideo, Minnesota, are hereby extended to include the unplatted territory described as follows, which territory now is and has heretofore been completely surrounded by territory already included within the city limits:

The East One Hundred Sixty-five (165') Feet in width of Lot Four (4) of Thompson's Subdivision of the West One-Half of the Northeast Quarter ( $W\frac{1}{2}$  of  $NE\frac{1}{4}$ ) and the East One-half of the Northwest Quarter ( $E\frac{1}{2}$  of  $NW\frac{1}{4}$ ) of Section Seven (7), Township One Hundred Seventeen (117), Range Forty (40), containing 1.37 acres.

Section 2. Filing. The city clerk is directed to file certified copies of this ordinance with the Secretary of State, the County Auditor of the county in which the property is located, and the Minnesota Municipal Commission.

Section 3. Effective Date of Annexation. This ordinance takes effect upon passage and publication and the filing of certified copies as directed in Section 2.
