Ordinance No. 380

AN ORDINANCE EXTENDING THE CORPORATE LIMITS
OF THE CITY OF MONTEVIDEO TO INCLUDE CERTAIN
LANDS ABUTTING UPON THE CITY LIMITS

WHEREAS, a certain petition requesting annexation of the territory hereinafter described was duly presented to the council on the 20th day of January, 1969; and

WHEREAS, the quantity of land embraced within the area described in the petition and bounded as described is .42 acres, no part of which is included within the limits of any incorporated city, village or borough; and

WHEREAS, the petition was signed by Arnold Lange and Loretta Y. Lange, the owners of the premises therein described; and

WHEREAS, no objections to the annexation have been received from the town board, the county board or the governing body of any municipality whose boundaries abut upon the boundaries of the land to be annexed; and

WHEREAS, the land described in the petition abuts upon the city limits at the Easterly boundary thereof;

The City of Montevideo does ordain:

Section 1. The City Council hereby determines (1) that the annexation will be to the best interests of the City and of the territory affected; (2) that the territory described herein abuts upon the City limits and is urban or suburban in character; and (3) that none of said territory is now included within the limits of any city, village or borough.

Section 2. Territory Annexed. The corporate limits of the City are hereby extended to include the land described as follows and the same is hereby annexed to and included within the City as effectually as if it had originally been a part thereof:

The East Half ($E\frac{1}{2}$) of Sublot Fourteen (14) in Wolfe's First Subdivision in the Southeast Quarter of the Southeast Quarter ($SE\frac{1}{4}$ of $SE\frac{1}{4}$) of Section Six (6), Township One Hundred Seventeen (117) North, Range Forty (40), containing .42 acres.

Section 3. Filing. The City Clerk is hereby directed to file certified copies of this ordinance with the Minnesota Municipal Commission, the Secretary of State, and the County Auditor.

Section 4. Effective Date. This ordinance takes effect upon its passage and publication and the filing of the certified copies as directed in Section 3.

PETITION FOR ANNEXATION

TO THE CITY COUNCIL OF THE CITY OF MONTEVIDEO, MINNESOTA:

We, the undersigned, the owners of the territory described below, hereby request the council to annex this territory to the city and to extend the city boundaries to include the same, and for that purpose respectfully state;

1. The territory to be annexed consists entirely of platted lands which are .42 acres in area. All of these lands lie entirely within the County of Chippewa, Minnesota, and the description of such lands is as follows:

The East Half (E $\frac{1}{2}$) of Sublot Fourteen (14) in Wolfe's First Subdivision in the Southeast Quarter of the Southeast Quarter (SE $\frac{1}{4}$ of SE $\frac{1}{4}$) of Section Six (6), Township One Hundred Seventeen (117) North, Range Forty (40), containing .42 acres.

2. The territory described above abuts upon the city limits at the Easterly boundary thereof and none of it is presently included within the corporate limits of any incorporated city, village or borough.

3. All of this territory is about to become urban or suburban in character.

4. Your petitioners request that these premises be annexed to the City of Montevideo.


