PUBLICATION NO. 1133 ORDINANCE NO. 316

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF HUTCHINSON AND ANNEXING THERETO CERTAIN LAND FORMERLY LOCATED IN THE TOWNSHIP OF LYNN.

THE KXXXXXXXXXXXXX OF HUTCHINSON DOES ORDAIN:

Section 1. A petition has been filed with the governing body of the City of Hutchinson, Minnesota, by Robert R. Roberts and Harriet Roberts, being the sole owners of the following described real estate, to have said property annexed and included within the corporate limits of the City of Hutchinson, County of McLeod, State of Minnesota, to-wit:

That part of the Northwest Quarter of the Northeast Quarter of the Southwest Quarter (NW\(\) of NE\(\) of SW\(\)) of Section 1, Township 116 North, Range 30 West, McLeod County, lying West of Roberts' First Addition, excepting therefrom the North 233 feet of the West 200 feet.

Section 2. The quantity of land embraced within the foregoing description, and bounded as described, is less than 200 acres.

Section 3. The City Council hereby determines: (1) that the annexation will be to the best interests of the City of Hutchinson and of the territory affected; (2) that the territory described herein abuts upon the City and is so conditioned as properly to be subjected to City Government.

Section 4. Therefore, the City of Hutchinson, Minnesota hereby ordains and declares that the property hereinbefore described be and the same is hereby annexed to, and included in the City of Hutchinson, Minnesota, as effectually as if it had originally been a part thereof.

Section 5. This ordinance shall be final and shall take effect and be in force after filing certified copy thereof with the Minnesota Municipal Commission, the County Auditor and the Secretary of State, and from and after its passage and publication.
