



ORDINANCE NO. 337

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY
OF HUTCHINSON AND ANNEXING THERETO CERTAIN LAND FORMERLY LOCATED
IN THE TOWNSHIP OF HUTCHINSON

THE CITY OF HUTCHINSON DOES ORDAIN:

Section I. A petition has been filed with the governing body of the City of Hutchinson, Minnesota, by George Herbert Jr. and Irene Herbert, being the sole owners of the following described real estate, to have said property annexed and included within the corporate limits of the City of Hutchinson, County of McLeod, State of Minnesota, to-wit:

The South 614.54 feet of the Southeast Quarter of the Southwest Quarter of Section 30, Township 117, Range 29, McLeod County, Minnesota, subject to existing easement for State Highway No. 15 and subject to an easement for County Road No. 76 over and across the Southerly 33 feet thereof.

Section II. The quantity of land embraced within the foregoing description, and bounded as described, is twenty (20) acres.

Section III. The City Council hereby determines: (1) that the annexation will be to the best interests of the City of Hutchinson and of the territory affected; (2) that the territory described herein abuts upon the City and is so conditioned as properly to be subjected to City Government.

Section IV. Therefore, the City of Hutchinson, Minnesota, hereby ordains and declares that the property hereinbefore described be and the same is hereby annexed to, and included in the City of Hutchinson, Minnesota, as effectually as if it had originally been a part thereof.

Section V. This ordinance shall be final and shall take effect and be in force after filing certified copy thereof with the Minnesota Municipal Commission, the County Auditor and the Secretary of State, and from and after its passage and publication.

Adopted by the City Council this 14th day of April, 1969.
