AN ORDINANCE EXTENDING THE CORPORATE LIMITS
OF THE CITY OF MOORHEAD TO INCLUDE CERTAIN
UNINCORPORATED, UNPLATTED LAND NOT EXCEEDING
200 ACRES IN AREA ABUTTING UPON THE CITY LIMITS.

WHEREAS, A certain petition dated January 18, 1968, requesting annexation of the territory hereinafter described was duly presented to the Council on February 6, 1968; and

WHEREAS, The quantity of land embraced within the area described in the petition and bounded and described is less than 200 acres and is unplatted land, no part of which is included within the limits of an incorporated city, village or borough; and

WHEREAS, The petition was signed by all of the owners of the property to be annexed; and

WHEREAS, No objections to the annexation have been received from the Town Board, County Board or the governing body of any municipality whose boundaries abut upon the boundaries of the land to be annexed; and

Whereas, a hearing was duly held by the governing body of the City of Moorhead, Minnesota, on the proposed annexation after a 30 days' posted notice; and

WHEREAS, The land described in the petition abuts upon the City limits at the southerly boundary thereof;

NOW, BE IT ORDAINED By the City Council of Moorhead, Minnesota:

Section 1. The City Council hereby determines that the annexation will be to the best interests of the City and of the territory affected; that the territory described herein abuts upon the City limits and is urban or suburban in character; and that none of said territory is now included within the limits of any city, village or borough.

Section 2. The corporate limits of the City are hereby extended to include the unplatted land described as follows and the same is hereby annexed to and included within the City as effectually as if it had originally been a part thereof:

All that parcel of land located in the Northeast Quarter of Section 20, Township 139, Range 48, Clay County, Minnesota, described as follows:

Beginning at a point of intersection of the North one-sixteenth (1/16th) line of said Section 20, and a line which is parallel to and Seven Hundred Seventy-two feet East (772'E) of the East Right of Way of Highway No. 75; thence East along said North one-sixteenth (1/16th) line of said Section 20; a distance of three hundred feet (300'); thence South perpendicular to the last described line a distance of Four Hundred Forty Feet (440'); thence West parallel to the said North one-sixteenth (1/16th) line to a point of intersection with a line which is parallel to and Seven Hundred Seventy-two Feet East (772'E) of the East Right of Way of Trunk Highway No. 75; thence North Four Hundred Forty Feet (440') to the point of beginning.

Section 3. The City Clerk is hereby directed to file certified copies of this Ordinance with the Minnesota Municipal Commission, the Secretary of State, and the County Auditor.

Section 4. This Ordinance takes effect upon its passage and publication and the filing of the certified copies as directed in Section 3.

The undersigned, the sole owners of the territory described below, does hereby request the City Council of the City of Moorhead to annex this territory to the City of Moorhead and to extend the City boundaries to include the same, and for that purpose respectfully represents and states as follows:

All that parcel of land located in the Northeast Quarter of Section 20, Township 139, Range 48, Clay County, Minnesota, described as follows:

Beginning at a point of intersection of the North one-sixteenth (1/16th) line of said Section 20, and a line which is parallel to and Seven Hundred Seventy-two feet East (772'E) of the East Right of Way of Highway No. 75; thence East along said North one-sixteenth (1/16th) line of said Section 20, a distance of three hundred feet (300'); thence South perpendicular to the last described line a distance of Four Hundred Forty Feet (440'); thence West parallel to the said North one-sixteenth (1/16th) line to a point of intersection with a line which is parallel to and Seven Hundred Seventy-two Feet East (772'E) of the East Right of Way of Trunk Highway No. 75; thence North Four Hundred Forty Feet (440') to the point of beginning.

2. That the territory described above abuts upon the City limits of the City of Moorhead at the South boundary thereof and none of said land is presently included within the corporate limits of any incorporated city, village or borough.
