ORDINANCE NO. 323

AN ORDINANCE FOR THE ANNEXATION OF CERTAIN LANDS INTO THE CITY OF ORTONVILLE, MINNESOTA.

The City Council of the City of Ortonville, Minnesota, does ordain:

Section 1. That the following described premises abutting the Municipal corporate limits of the City of Ortonville, Minnesota, be and are hereby annexed and brought within the corporate limits of the City of Ortonville, Minnesota, to-wit:

South Sixty-two feet (S62') of Outlot One (1) of Government Lot Four (4), Section Five (5), Township One Hundred Twenty-one (121), Range Forty-six (46),

Section 2. This Ordinance shall be in force and effect from and after its passage and publication according to law.
