

ORDINANCE NO. 56

An ordinance extending the limits of the village of Pine River, to include Wideman's Addition, Snell's Addition, and other adjacent land.


The Village Council of the Village of Pine River do ordain as follows:

Section 1. The limits of the village of Pine River are hereby extended to include the land hereinafter described, and the said land is hereby included within the limits of said village. Said land is described as follows: All of Wideman's Addition to the village of Pine River; also a tract described as follows: That portion of the Northeast quarter of the Southwest quarter ($NE\frac{1}{4}$ of $SW\frac{1}{4}$) of Section Thirty-one (31), in Township One hundred Thirty-eight (138) North, Range Twenty-nine (29) West of the 5th P. M., lying west of Norway Brook, including all of Snell's Addition to the village of Pine River, and other land, but not including any land west of the county road running along or near the west line of said tract.

Section 2. This Ordinance shall be in force and effect from and after its publication, and the filing of a certified copy thereof in the Office of the Secretary of State.
