ORDINANCE NO. 103, NEW SERIES

AN ORDINANCE DETERMINING THE ANNEXATION OF CERTAIN LAND TO BE IN THE BEST INTERESTS OF THE CITY OF LUVERNE AND OF THE TERRITORY AFFECTED AND DECLARING SAME TO BE ANNEXED TO THE CITY

THE CITY OF LUVERNE DOES ORDAIN:

Section 1. The following territory, consisting of unplatted land not exceeding two hundred (200) acres in all, abutting upon the City of Luverne, Rock Sounty, Minnesota, being so conditioned as properly to be subject to municipal government and not included in any other municipality, upon petition of all the owners in number, and in the best interests of the City of Luverne and of said territory, is hereby declared to be annexed to the said City, to-wit:

A Tract of land in the Northwest Quarter (NWA) of Section Fourteen (14) in Township One Hundred Two (102) North, of Range Forty-five (45), West of the 5th P.M., described as follows: Beginning at a point on the west line of said Section 14, 1040.92 feet south of the northwest corner thereof thence deflect left 90°00' to the east line of the right-of-way of the Chicago, St. Paul, Minneapolis & Omaha Railway, now abandoned, thence southerly on the east right-of-way line of said abandoned Railway to its point of intersection with the north right-of-way line of Interstate Highway No. 90, thence in a northwesterly direction on the north right-of-way line of said Interstate Highway No. 90, and the westerly projection of said line to the west line of said Section 14, thence northerly on the west line of said Section 14 to the point of beginning, subject to pole, utility, highway and right of access easements.

Section 2. The above described territory shall be incorporated in and become a part of the South Ward, Southwest Precinct, of the City for election purposes until otherwise designated by the City Council as provided by law.

Section 3. This ordinance shall be in full force and effect thirty (30) days after its passage and publication, and the annexation provided for herein shall be deemed final upon filing a copy hereof with the Minnesota Municipal Commission, the Rock County Auditor and the Secretary of State.
