ORDINANCE NO. 1160

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF AUSTIM TO INCLUDE CERTAIN UNPLATTED LAND NOT EXCEEDING 200 ACRES ABUTTING THE CITY LIMITS.

WHEREAS, a Patition was filed requesting the annexation of the territory hereinafter described, which Patition was duly presented to the Common Council on the 21st day of April, 1969, and

WHEREAS, the quantity of lands embraced within the erea described in the Petition and bounded as described is 120 acres of unplatted land, no part of which is included within the limits of an incorporated city, village or borough, and

WHEREAS, the Petition was signed by all the owners, and

WHEREAS, no objections to the annexation have been received from the Town Board, the County Board or the governing body of any municipality whose boundaries abot upon the boundaries of the land to be annexed; and

WHEREAS, the land described in the Petition abuta upon the City of Austin at the North boundary thereof;

THE COMMON COUNCIL OF THE CITY OF AUSTIN DO ORDAIN:

SECTION 1) The City Council hereby determines, 1) that the annexation will be to the best interests of the City and of the territory affected. 2) that the territory described herein abuts the city limits, and is about to become urban or suburban in character, and 3) that none of said territory is now included within the limits of any city, village or borough.

SECTION 2) The corporate limits of the City of Austin are hereby extended to include the unplatted land described as follows, and the same is hereby ammexed to and included within the City of Austin as effectually as if it had originally been a part thereof;

> Land in Mower County, Minnesota, described as follows: The following portions of Section 35, Township 103 North, Range 18 Rest: That part of the Sest half of the Northwest guarter of Section 35 and the Northeast guarter of the Southwest quarter of said Section 35 lying East of the right-ofway of the Chicago, Milwaukee, St. Paul and Pacific Reilroad Company; and the West half of the Northeast quarter of Section 35 and the Northwest quarter of the Southeast quarter of said Section 35 except that part thereof lying East of the West line of the land annexed to the corporate limits of the City of Austin by Ordinance no. 1088 dated July 18, 1966, and subject to the right-of-way of the Chicago and Northwestern Railway Company, Formerly Chicago Great Western Railway Company. That part of Northeast one fourth of Northeast one fourth of said Section 35 lying West of Northwesterly line of right-of-way of said Chicago and Northwestern Railway Company and North of line beginning on East line of said quarter quarter Section et a point 66.0' South of the Northmost corner thereof and running Westerly through said quarter quarter section on a course parallel to North line thereof.

SECTION 3) The City Recorder is hereby directed to file certified copies of this Ordinance with the Minnesota Municipal Commission, the Secretary of State and the County Auditor.

SECTION 4) The Ordinance takes effect upon its passage and publication and filling of the certified copies as directed in Section 5.
